INFORMATION WE COLLECT FROM YOU

Contact information (HC game test request form)

To share with us your new casual games ideas and send us a gameplay video you want us to asses, you will be asked to provide us with your name, email address, gameplay video link, game name, link to your games portfolio, description of your game and link to the messenger where we can contact you.

We will use this information solely to assess your game and the possibilities of your future cooperation with us as a publisher, and to contact you back.

Account information

To use all functions of the Service, you will have to create a user account. We will collect your name and email address for setting up your account. Also, you may add additional account information such as a profile photo to customize your account.

Service usage statistic data

During your use of the Service, we collect your IP logs. The data categories we receive may include the model of the device, operating system version, country of geolocation, user ID, date, time, and duration of the user session, pages viewed, links clicked. We use this data for Service security, debugging, and Service improvement purposes.

Additionally, the information we collect via the Service depends on the content and materials you use, includes:

Derivative Data

Consent
