Information Collection and Use

Furthermore, the app may integrate third-party services that independently collect user information. For example, the app includes:

- Google Play Services

Log Data

In case of an app error, we may collect data such as your device's IP address, model name, OS version, app configuration at the time, timestamp of usage, and other diagnostic details through third-party analytics tools. This "Log Data" helps us identify and address issues more effectively.

Cookies

Cookies are small data files that websites and certain web services store on your device. While our application itself does not use cookies, some embedded third-party tools may do so to enhance performance and collect analytics. You can control cookie behavior in your browser settings, including disabling them or receiving notifications. Disabling cookies may affect certain features within the app.

Third-Party Service Providers

We may collaborate with third-party entities to:

- Deliver the Service;
- Perform certain tasks on our behalf;

- Support app functionality; or
- Analyze how the app is used.

These third parties are granted access to personal information only to the extent necessary to perform their tasks. They are contractually obligated to safeguard your data and are prohibited from using it for unrelated purposes.

Security

We prioritize the protection of your personal data and employ industry-standard methods to keep it secure. However, due to the nature of digital data transmission and storage, absolute security cannot be guaranteed.
