responsible for your data. Users do not register in any way within our application, nor do we track their actions while using our application.

The only information that is transmitted off your device in connection with our application/service is your device information that Google ad services (AdMob) use for personalization of your ad experience. This includes the device's ID information used by Google Services. It is important to understand that we at FletchTechLabs do not store this information in any way and it is transmitted directly to Google AdMob.

The only event that we would have any access to your personal information is when you submit a contact email to our support team through our application. This process uses whatever your selected email provider is on your device and the information transferred to our Google email account would be whatever information you have chosen to share with our team. We encourage you to NOT provide information that is not relevant to the support topic. Having your name, address, or other personal information does not assist our team in working on your support cases, so please only include the issue in question in your emails. If you only include the issue in your email body, the only information that we will receive is your body and your email address.
