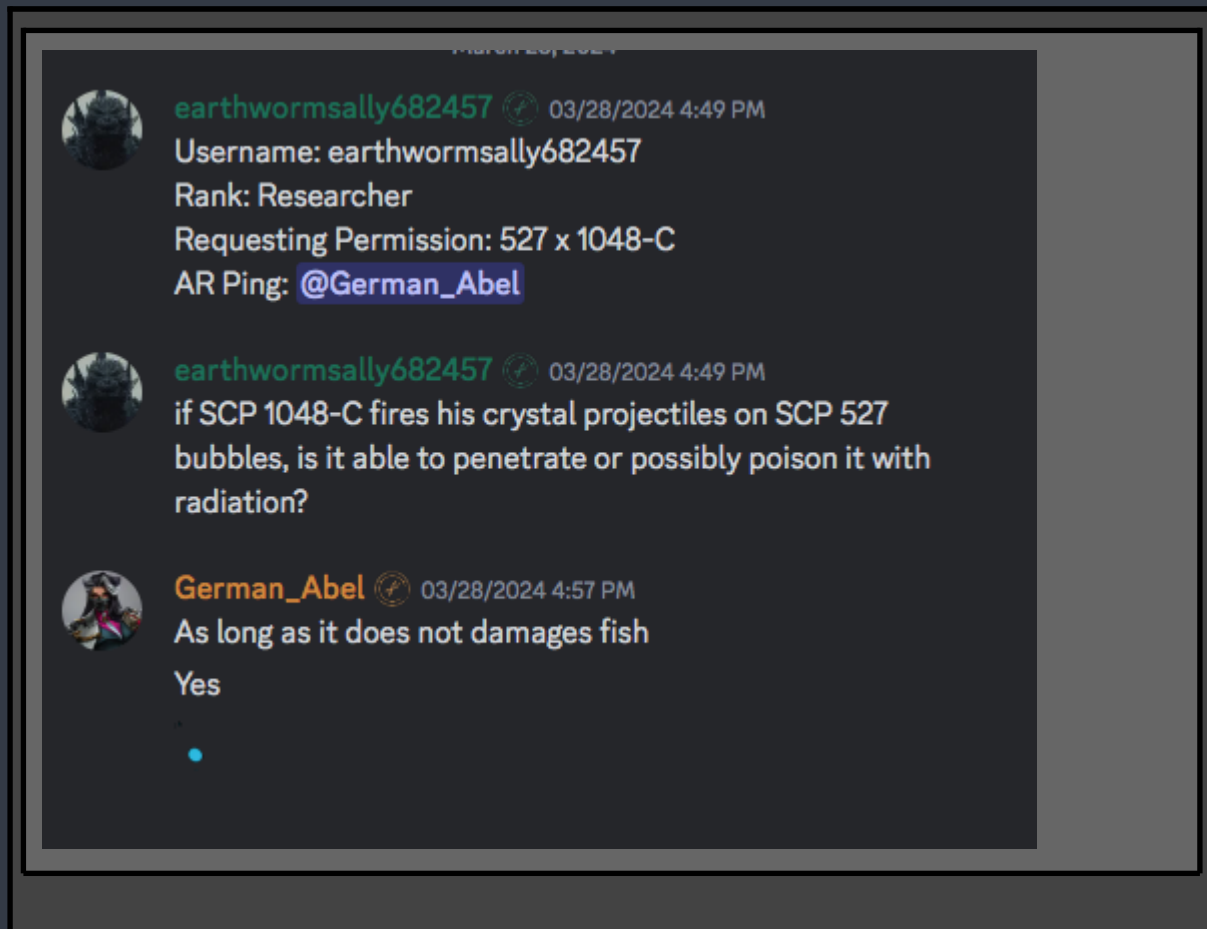

## METHOD

### TESTING RESULTS:

### PRE TESTING METHOD:

27. We tried a normal bubble.
28. *Fish* fired the bubble.
29. *Nuke*, charging himself, released a deadly salvo of projectiles alongside with other attacks which also popped the bubble.
30. We tried this one last time with a bullet bubble.
31. *Fish* fired the bubble.
32. *Nuke*, charging himself, released a deadly salvo of projectiles onto the bubble alongside other attacks. The same result happened and it popped the bubble.
33. After we realized that *Fish* bubbles are not invincible, I then concluded the test and left.

## ————RESULTS————

### CONCLUSION:

[The aftermath of this test was to see how powerful are *SCP 1048-C* projectiles compared to *Fish* bubbles, for the first time ever, *Fish* bubbles have finally been popped.
