Awards:

Awards will be handed out at the conclusion of each trial. Ribbons are awarded for qualifying score, Best of Breed and High in Class. New title ribbons will be awarded.

Venue:

~This event is being held at at Flying M ranch.

~Exhibitors can crate in their vehicles or setup their own canopy outside. Restroom and water on-site for both locations.

~Complimentary Breakfast items will be out each day. A sandwich bar will be available for everyone.

~ Dry Camping available at the ranch. Complete the Camping form and return to trial secretary.

Montana K9 Sports reserve the right remove any individual for any reason from the premises. No refunds will be issued.

Notice to Exhibitors:

- Refunds will be mailed 7 days after the event.
- No refund for cancellations after the closing date.
- No refunds will be made for cancellations after the closing date or entries which are absent, disqualified, excused or barred from competition by decision of the Trial Committee.
- Exhibitors are responsible for complete, accurate and legible information on their entry forms.
- It is expressly understood that exhibitors alone are responsible for behavior of their dogs, children and/or guests. Any exhibitor whose dogs, children and/or guests repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Trial Committee, be asked to leave the trial site. In such case, no refund on any entry will be made.
- All dogs must be on leash at all times except when competing.
- Exhibitors are responsible for being in the staging area when it is their turn to run.
- Please be courteous and pick up after your dog.
- Bitches in Season may compete in the event. The Trial Secretary must be notified in advance, BIS will run last in their class, and panties must be worn when dog is outside of vehicle (except to potty). A potty area near the parking area will be designated for BIS.
- Move ups from Trial to Trial and Day to Day are allowed. A move up form must be completed for Day to Day Move Ups. Judge & Trial Secretary must be notified in advance for Trial to Trial moveups.
- All entries must be accompanied by entry fees to be valid. A declined payment or returned check does not constitute a valid entry. There will be a \$45 fee for any returned check or payment. Checks must be made payable to **Jessica Clough. Email Entries Accepted. 5% fee, max \$20 for PayPal and CC/Debit payments. No fees for Venmo payments. Or enter**
