

## Privacy Policy

We recognize and value the protection of your personal information ("data"). This Privacy Policy ("Policy") sets out the ways that we may collect, use, disclose and protect your personal information when you download and use The Witch's Gift (the "App" or "Service").

### Collection Of Information

Email address: your email address will only be collected when you contact us or actively provide it to us.

Device data: device model, manufacturer, language, screen resolution, operating system, network type (wifi, 4g, 5g), advertising ID (IDFA, IDFV, GAID), Mac address.

Log data: your actions and interactions in the app, such as the links and objects you view, click, or otherwise interact with, and the length of time you use the App.

### Use Of Information

We may use your information to:

- communicate with you, to provide the Service,
- comply with any applicable legal obligations, and
- protect or defend the Service, our rights, and the rights of our users or others.

### Disclosure Of Information

We may disclose personal information and non-personal information we collect to third parties, such as advertisers, marketing partners, and others who provide our content or products or services we think may be of interest to you.

We may engage trusted third-party service providers to perform functions and provide services for us, such as hosting and maintaining our servers and services, database storage and management, and customer service, data analysis.

We may also disclose your information to government or law enforcement officials to respond to claims, legal process (including subpoenas), to protect our rights and interests or the rights and interests of third parties, the safety of the public or any person, to prevent or stop any legal, unethical or illegal actionable activity, or otherwise comply with applicable court orders, laws, rules and regulations.

### Children's Personal Information

The App is not intended for children under 13 years old. We do not knowingly collect personal information from children under 13 years old. We follow all applicable data protection laws when collecting personal information online from children, including by obtaining parental consent where required, based on the applicable age standard.

### Your Rights

You can request to access, obtain a portable copy of, correct, or delete data related to your stored preferences and your use of the App. Please note that we may take steps to verify your identity to enable us to respond to your request.

#### Retention of Information

We will retain your personal information as long as necessary to fulfill the purposes outlined in this Policy, including to satisfy our legal or reporting requirements, unless a longer retention period is required or allowed under law.

#### Security of Information

We implement reasonable measures to help secure the information we collect through the Service. It is our policy to retain personal data only for as long as is necessary for the fulfillment of the purposes for which the data are to be used, or as required by law, regulation or professional standards and in order to establish, exercise or defend our legal rights.

#### Third-Party's Services

The App may contain links or integrations to third-party services. We cannot control the personal information collected, stored or used by third parties, and are not responsible for their information processing. The processing of your information by these third parties is subject to their privacy policies.
