### PUBLIC CHARGING STATIONS ACT

---

#### SUMMARY

An act to establish public charging stations throughout the Kingdom of Stormwind for use by mechnomes and mechanical constructs.

## ARTICLE I - GLOSSARY OF TERMS

- A. **Mechanical Construct** - any entity, living or otherwise, permitted within the Kingdom of Stormwind by the [Legal Designation of Races Act](#).





## ARTICLE II - PROCEDURE

- A. The Kingdom of Stormwind shall offer public charging stations, free of use, to any mechagnome or mechanical construct legally permitted within the Kingdom of Stormwind by the [Legal Designation of Races Act](#).
1. These charging stations will permit the user to charge themselves via the use of electricity in order to continue their functionality.
  2. Improper use of charging stations will result in the improper user being arrested for vandalism in accordance with the [Crimes of the Kingdom Act](#) and potentially sued in the Stormwind Ministry of Administration's Crown Tribunal for the sum of money required to repair any broken or damaged charging stations.
- B. Public charging stations will be available in the following locations:
1. Cathedral Square Clinic in Stormwind City (Cathedral Square)
  2. City Hall in Stormwind City (Cathedral Square)
  3. Darkshire Clinic in Darkshire
  4. Deeprun Tram in Stormwind City (Dwarven District)
  5. Stockades (Stormwind City, Mage Quarter)
  6. Stormwind Embassy in Stormwind City (Unincorporated)
  7. Stormwind Harbor in Stormwind City (Harbor)
  8. Lakeshire Clinic in Lakeshire
  9. Marshtide Watch Medical Tent in the Stormwind Territories
  10. Westfall Field Clinic in Unincorporated Westfall

- C. The establishment and maintenance of charging stations shall be the responsibility of the Stormwind Ministry of Administration's Public Construction Commission.



## ARTICLE III - FUNDING

- A. Funding for the implementation of this legislation will be provided through the Stormwind Ministry of Services' budget for the Public Construction Commission.
