Product Introduction

This "Privacy Policy" (hereinafter referred to as [this Policy]) explains how Trading Trainer app will collect and process your personal information and private information. The Trading Trainer app will strictly abide by laws and regulations, and provide you with safe and reliable services.

Information We Collect

In order to provide you with our services, we need you to provide information necessary to use the services. We will only collect information that is necessary to achieve specific, specific, explicit and lawful purposes and will not subject this information to further processing that is incompatible with the aforementioned purposes. You have the right to choose whether to provide the information we request, but in most cases, if you refuse, we may not be able to provide you with the corresponding services, nor respond to the problems you encounter.

Information you voluntarily provide when using our services

Information we collect during your use of the service

Device and application information. Such as device model, IMEI, ANDROID

Information such as ID, device identifier, device serial number, operating system version, signal strength, app version number, browser type and settings.

Mobile network information. Such as Public Land Mobile Network Provider ID (PLMN), Internet

Protocol (IP) address.

Exceptions to Authorized Consent

You fully understand and agree that we do not need your authorization to collect and use your personal information under the following circumstances:

Related to national security and national defense security;

Related to public safety, public health, and major public interests;

Related to judicial or administrative law enforcement such as criminal investigation, prosecution, trial and judgment execution;

Unable to obtain your timely authorization under special circumstances in order to protect the safety of your life or property;

Collect your personal information from other legally disclosed channels;

Other circumstances stipulated by laws and regulations.

How we use the information we collect

We strictly abide by the provisions of laws and regulations and the agreement with users, and use the collected information for the purposes described in this policy. We may use your personal information for the following purposes: s

Safety protection for purposes such as loss prevention and fraud prevention, assisting in identifying users, verifying identities, etc.;

for data analysis, research and development of statistical information related to the use of our services;

Store and maintain information about you for the purposes of our business operations or to comply with legal obligations;

Send notifications;

Improve user experience;

Other purposes with your consent;

How we use cookies and similar technologies

Device permission call

In the process of providing services, we may require you to enable some device permissions, such as access permissions for notifications, photo albums, and cameras. You can also choose to turn off some or all permissions at any time in the settings function of the device, thereby rejecting our collection of corresponding personal information. How do we share, transfer and publicly disclose your personal information

Shared

We will not share your personal information externally, except in the following cases:

After obtaining your explicit consent, we will share the information within the scope of your authorization with the third party you designate;

We may share your personal information externally in accordance with the provisions of laws and regulations, the needs of litigation dispute resolution, or the legal requirements of administrative and judicial authorities;

Your information may be shared within our affiliated companies. We will only share your information within our affiliates for specific, clear and lawful purposes, and will only share information necessary to provide services;

Your information may be shared with our business partners to ensure the smooth completion of the services provided to you. However, we only share your personal information for legal, legitimate, specific, and clear purposes, and we will only share personal information necessary to provide services.

Transfer

We will not transfer your personal information to any company, organization or individual, except in the following cases:

After obtaining your explicit consent, we will transfer your personal information to other parties;

When it comes to mergers, acquisitions or bankruptcy liquidation, if personal information transfer is involved, we will require the new company or organization holding your personal information to continue to be bound by this statement, otherwise we will require the company to , The organization asks you for authorization again.

Public Disclosure

We will publicly disclose your personal information under the following circumstances:

With your express consent;

Public disclosure based on legal or reasonable grounds: We may publicly disclose your information when required by law, legal process, litigation, or public and governmental authorities.

How we store and protect your personal information

We have adopted industry-standard, reasonable and feasible security measures to protect your information and prevent personal information from unauthorized access, public disclosure, use, modification, damage or loss.

We will take reasonable and feasible measures to avoid collecting irrelevant personal information. We will only retain your personal information for the period necessary to achieve the purposes stated in this policy, unless there is a mandatory retention requirement by law.

The Internet is not an absolutely safe environment. When using the services we provide, we strongly recommend that you do not use communication methods not recommended by our official platform to send your information.

Please note that the information you share voluntarily or even publicly when using our services may involve personal information or even sensitive personal information of you or others. Please consider more carefully whether to share or even publicly share relevant information when using our services.

In the event of an unfortunate personal information security incident, we will inform you in accordance with the requirements of laws and regulations: the basic situation and possible impact of the security incident, the disposal measures we have taken or will take, and you can prevent and reduce risks independently suggestions, remedial measures for you, etc.
