

STANDARDS FOR DRESS (revised 7/20)

The following Standards for Dress have been developed to promote school unity and a safe learning environment in which there are minimal distractions and disruptions, and one that conveys standards appropriate for work. Reasonable care and neatness in regard to dress and appearance is required for all students.

REQUIRED DRESS:

1. When on campus, each student shall have their school I.D. card in their possession ***or on their cell phone** and present it when needed or asked.
2. **Top: School approved shirts shall be worn at all times (includes school, class, clubs, athletics, etc.) or single, solid color shirts which adhere to the restrictions outlined below. Shirts shall not be modified / altered without prior administrative approval.**
3. **Bottoms:** Tears, rips or other openings in bottoms must be below the mid-thigh. The bottoms of all clothing shall be, at least, mid-thigh length.
4. Shoes or slippers shall be worn.
5. Outerwear consists of jackets and sweaters. An approved shirt shall be worn underneath all outerwear.
6. ***Due to COVID 19 - face masks must be worn.**

BEAR PRIDE DRESS DAYS:

1. ***On MONDAY, students are encouraged to wear MAROON colored clothing. All clothing should adhere to the required dress.**
2. ***On TUESDAY, students are encouraged to wear BLUE colored clothing. All clothing should adhere to the required dress.**
3. ***On WEDNESDAY, students are encouraged to wear WHITE colored clothing. All clothing should adhere to the required dress.**
4. ***On FRIDAY, students are encouraged to wear ALOHA / HAWAIIAN print. All clothing should adhere to the required dress.**
5. Administrative approved alternative dress days are designated days based on activities such as Spirit Week. Details on these days will be specified per event. Participation is optional. Students electing to not participate shall wear the normally required dress.

RESTRICTED DRESS AND ACCESSORIES

1. No clothing, hats, jewelry, or other accessory that displays inappropriate or obscene messages or depicts sex, gang, drugs, alcohol, tobacco or violence, messages or symbols which promotes a lack of tolerance for diversity shall be worn.
2. No tube tops/bandeaus, strapless, off the shoulder, spaghetti strap, bathing suits, halter or backless tops/dresses shall be worn as outerwear. A student's chest, midsection, shoulder, and back shall not be exposed. Tears / openings in bottoms may not be above the mid-thigh.
3. No dresses or skirts, which cling to the body and that ride up, shall be worn. (e.g. Body Con)
4. No pajamas, leotards, or sheer bottoms shall be worn as outerwear.
5. No sunglasses may be worn indoors.
6. No bandanas of any kind/color are permitted.
7. No tattoos depicting sex, gang, drugs, tobacco, violence, or obscenities shall be visible.

CONSEQUENCES:

Students out of dress code shall be given a loaner. The student's original clothing is kept in the office until the end of the day. The student is expected to return to the office to collect their clothing and return the loaner. Parents may be called if the student hasn't collected their clothing/returned ours to prompt the return. Failure to complete this process then results as a \$5 obligation, at the end of the quarter. This obligation could also be cleared by returning the clothing. Clothing not picked up by the last student day at the end of a school year shall be donated.

1st offense:	Class D referral for violation: change into loaner shirt
2nd offense:	Class D referral for violation change into loaner shirt
3rd offense:	Class C referral for insubordination: change into loaner shirt
	Detention, suspension, or revocation of school activity privileges may be assigned as determined by administration

If an appropriate loaner is available, the student will be required to change clothes. Inappropriate hats/jewelry/accessories shall be confiscated and parents may be asked to pick it up.
