Articles prepared in accordance with the principles of writing and approved by the review board are published.




Figure 1. This is the example of figure formatting

#### 3. Results

References, tables, figures to be used must be prepared in accordance with APA. Articles that do not comply with the rules of writing and APA are eliminated in the first stage by the editor.
