- We will **never sell, license, publish, or use your cloned voice** for any purpose other than the services you request.
- We will never impersonate you, misrepresent you, or allow third parties to use your cloned voice.
- You may revoke permission at any time, and your voice model will be deleted immediately upon written request.

Your Authorization:

By supplying audio for cloning, you authorize us to:

- Create your voice model
- Use it solely for producing content that you approve or request
- Store your voice model securely within ElevenLabs or similar vendors

You retain all rights to your own voice.

4. Sharing Your Information

We do **not** sell your data.

We only share information with trusted third parties necessary to deliver your services.

These providers are contractually prohibited from misusing your data.
