INTRODUCTION (12 pt Times New Roman)

The Introduction section must be written with a total length of 5,000 to 7,000 words, providing a comprehensive and in-depth background for the study. It should present the objectives of the article or research, formulated and introduced through a well-developed context. This section must avoid overly detailed citations and refrain from including research results. The urgency of the study should be convincingly conveyed through the inclusion of relevant data, supporting facts, and references to current issues or challenges. Preliminary findings or prior observations should also be described to establish a solid foundation for the research. Before explicitly stating the research objectives, the Introduction must feature a gap analysis, a critical explanation of the differences between the current study and prior research. This analysis should identify underexplored areas or unresolved problems that the present research seeks to address. Through this, the novelty or originality of the study becomes apparent. Finally, the Introduction should clarify the research stance, specifying whether the study intends to extend, challenge, or support existing literature.

METHODS (12 pt Times New Roman)

The method used must be accompanied by references; any relevant modifications should be explained. Procedures and data analysis techniques need to be emphasized, especially in literature review articles. The stages and analysis in the research must be described in detail.

RESULT AND DISCUSSION (12 pt Times New Roman)

Results and discussion should be presented in a single, clear, and concise section. The discussion section must explain the significance of the research findings, rather than repeating the results. Combining results and discussion into one section helps to avoid overly lengthy quotations. Tables or figures should present distinct findings. The results of data analysis must be reliable in addressing the research problem. References in the discussion section should not repeat those used in the introduction. Comparisons with previous research findings must be included.

CONCLUSION (12 pt Times New Roman)

The research conclusion should be presented briefly, in a narrative form, not as bullet points, and should be conceptual in nature. The impact of the research must be stated.

REFERENCES (12 pt Times New Roman)

References in the article must include the author's last name and the year of publication. When citing multiple sources, they should be arranged starting with the most recent. If citing a work by two authors, both names must be included. However, for works by three or more authors, only the first author's name should be listed, followed by *et al.* All citations must also be included in the reference list. Every cited source must be fully referenced in the bibliography. Unpublished sources are not recommended for citation. References must follow APA style. This journal requires that 80% of the cited references come from national and international journals.
