

# Terms of Use

**Last Updated: 17.09.2025**

These Terms and Conditions of Use (the “Terms”) apply to the websites, newsletters, and event registration platforms operated by **RD2 Sports Limited**, doing business as **No Limits Tour (“NLT”)**, **NLT Cliff Diving**, **NLT Cliff Diving Championship**, and related variations (collectively, the “Sites”).
