Zone 5 - No Update

- 479 Whitehall St SW: Male killed by a private citizen.
- Cru (301 Peters): Cited by the License and Permits Unit on April 10, 2026, for operating after hours. Peter Street Station was reviewed, and it shows an event hall. We will add this location to investigate further.
- 300 Peters: On 5/08/2026, the Zone 5 FIT team conducted a detail in the area of 300 Peters Street in response to the 5/05/2026 shooting involving an individual illegally parking vehicles there. The team conducted surveillance of the area and identified one male, Mr. Santerrio Thomas, in the roadway illegally parking vehicles. Officers moved in and arrested Thomas. Thomas is similar in appearance to the shooter and officers contacted the Aggravated Assault investigator regarding his arrest. After speaking with the investigator, officers transported Thomas to City Jail
- Greyhound & Forsyth Street crime/convenience Store: Shooting 4 shot
- 375 Luckie St: They seem to be operating under a different name from the one in the application. They only discuss a downstairs lounge and an event space upstairs. They are advertising a rooftop bar which was not part of the application and not approved.
- Insomnia Nightclub: Within the Underground Atlanta district blocking sidewalks from pedestrian traffic
- Roots and Beats (261 Peters): Doing 5am to 10am parties every Saturday and Sunday.

Zone 6 - No Update

- Cru Edgewood (367 Edgewood): Shooting on Edgewood 6/10/2026 originating from CRU
- Renaissance Park (501-515 Piedmont): Mailbox break-ins
- Duke's Hideaway at McCray's Tavern on the Beltline (670 DeKalb Ave): Has been receiving a significant amount of noise complaints within the last several months. This chronic problem is affecting residents' quality of life, and from observation is operating at unacceptable levels to where the establishment management and APD are also well aware.
(Applicant has met with the community about this and has stopped the DJ's and will

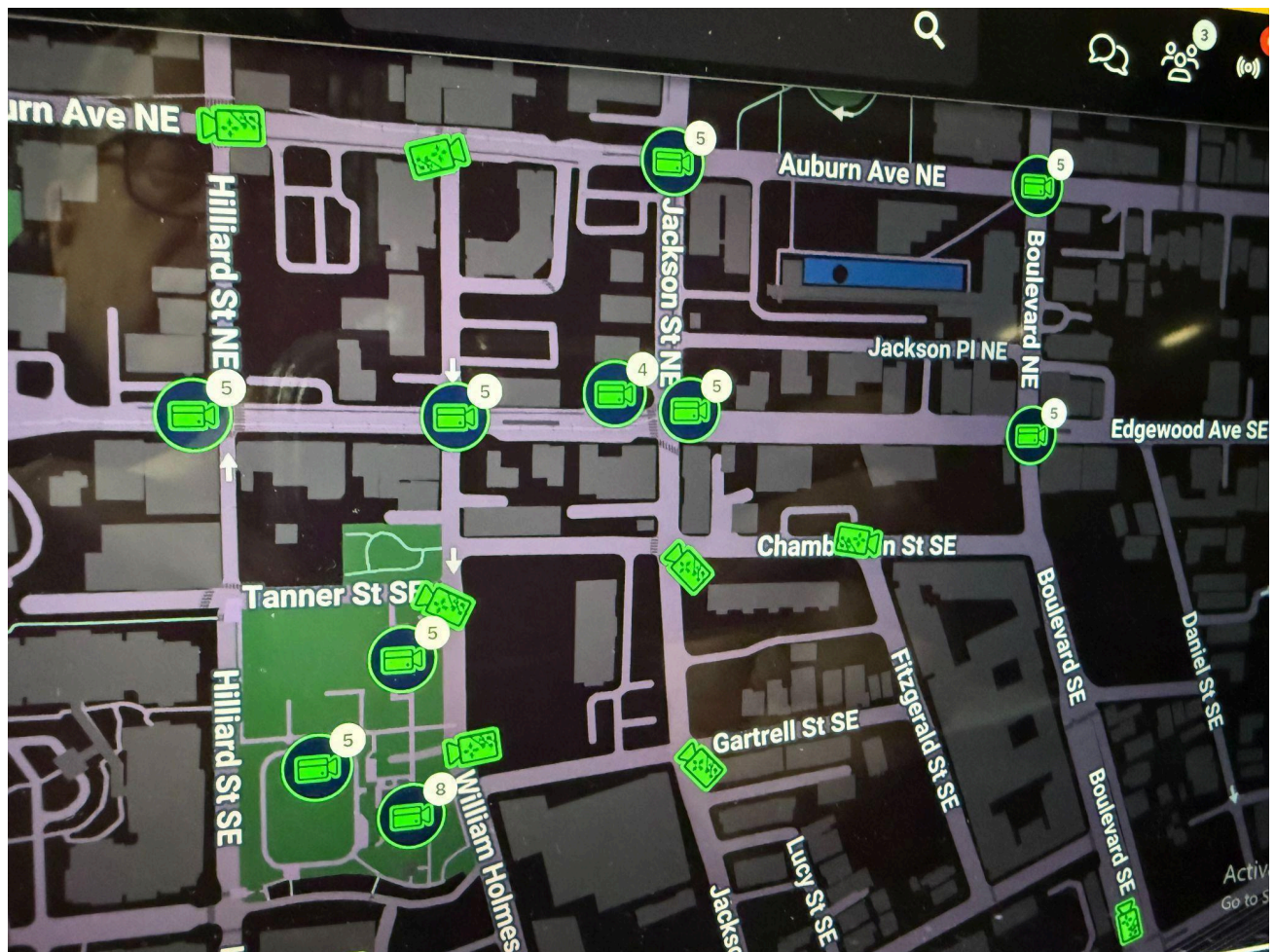
continue to work with the community in resolving the issue. Public Safety volunteered to help with the community conversation if he need us.)

- Iconz Sport Bar (447 Edgewood): Noise compliant again (does not have Entertainment on Application for alcohol and should not be blasting music). **Working with License and Permits on this location.**
