I. AoR update

- New GPC Coordinator has started Josep Herreros
- GPC conference June 10-14 venue still to be confirmed, but will included dedicated HLP AoR days and time with wider protection cluster, AoRs and partners
- Information Management (see <u>presentation here</u>)
 - o HLP PiN and Severity Task Team TOR being finalised, shared soon.
 - Task Team aims to develop methodology to estimate PiN and severity scale for HLP AoR and Working Groups

 - o Global HLP AOR Dashboard nearly ready to be published captures people in need, people targetted, funding. Also, HLP mapping webpage being developed
 - o Joint Intersectoral Analysis Framework (JIAF) 2.0

- JIAF designed to designed to improve the way humanitarian actors jointly plan and respond to crises.
- Lessons Learned workshop in January 2024 following roll-out in 25 countries for HPC 2024 process
- Recommendations included:
 - RC/HC requests Heads of Agencies at country level that clusters are adequately staffed ahead of HPC process;
 - Review outcome indicators/proxy indicators and if they are working: both utility & accuracy
 - Develop clear guidelines on how to define and agree scope of analysis and apply scope during analysis
 - Global Clusters and OCHA to support REACH/DTM efforts to start major assessments earlier
 - Have more offline, self-learning materials, including lite/refresher modules
 - Standardize the duration and timing of country-level ICCG training on JIAF

Colleagues expressed interest to join the Task Team. Request to also develop guidance on emergency HLP activities for clusters and sectors

2. Myanmar - HLP rights

- presentation from Jose Arraiza Independent Researcher, collaborating often with ProCap, NRC, UNDP, and other actors dealing with protection and land issues.
- Co-author of new book https://www.amazon.co.uk/Before-Democracy-Died-Housing-Property/dp/9819970539
- Set out HLP-relevant timeline for Myanmar, including impact on HLP rights of recent coup:
 - Land grabbing and irregular extraction of natural resources
 - Destruction of housing and other properties
 - Mass displacement of ethnic minorities and vulnerable groups
 - o military capture of land administration and management bodies
 - o strengthening of ethnic armed organisations and customary land systems
 - o restrictions of civic space
 - o impact on women and girls
 - increasing vulnerability to climate change

- Suggested HLP protection approaches included:
 - Strategic legal aid work methodologies that reduce the risks faced both by CSOs and farmers and adapt to the context
 - Creative measures to protect lands from being grabbed and to promote the recognition of customary tenure
 - People centered justice: Methodologies to resolve disputes building Collaborative
 Dispute Resolution skills at the village level
 - o Community led climate resilience through land use
 - Research on federalism and NRM/land governance
 - Strategies to improve CSO resilience and ensure "do no harm" and due diligence
 - Digital safety support

3. Ethiopia - HLP Rapid Needs Assessment, Tigray and Somali regions

- Presentation from HLP Working Group Coordinator, Bereket Fetene (NRC ICLA Specialist, Ethiopia)
- Key findings from assessment included the following HLP issues:
 - Lack of /loss of documentation,
 - Destruction of housing and property,
 - Secondary occupation,
 - Informality of tenure arrangements
 - Fraudulent HLP transactions, and
 - Lack of functional dispute resolution mechanisms
- Recommendations included:
 - Humanitarian interventions need to consider the high rates of secondary and illegal occupation when designing programming in a community
 - Consider establishing a mass-claims mechanism for conflict-related property claims in Tigray
 - More work is needed to understand the roots of dissatisfaction with HLP dispute resolution mechanisms
 - Displacement-affected communities need access to HLP documentation.

HLP country briefs (Emily)
 Development by IOM and American University of HLP briefs for Nigeria, Somalia,
 Mozambique and Ethiopia.

From the team: "Our focus is primarily on understanding and demystifying various land tenure frameworks and arrangements, as well as understanding relationships between IDPs and various actors and host communities. We are right now focusing on four countries: Nigeria, Somalia, Ethiopia, and Mozambique.

Our research will be used to create briefing papers for practitioners that will summarize, describe, and demystify land tenure and property rights challenges for IDPs. We plan to overview all of the relevant statutory laws and customary laws and practices that affect land tenure security. Some key areas of concern are evictions and secondary

displacements, understanding how property claims disputes are settled, land use and resource use governance, and how gender affects tenure security and property rights.

Additionally, we plan to incorporate an actor mapping component to identify all of the key stakeholders and actors relevant to land tenure in regions with significant IDP populations to help practitioners and cluster members better navigate potential challenges."
