The Church of Conscious Harmony, legally, is a 501(c)3 non-profit organization, located in Austin, Texas, USA. We are a contemplative, non-denominational Christian church which offers regular church services, classes and retreats.

App Powered by Pushpay

Personal information CCH collects

The personal information that CCH collects about you through the App depends on how you interact with us:

- *Information that you provide voluntarily*
CCH collects certain personal information from you when you choose to provide us with this information on or through our App, including but not limited to your first and last name, address, email address, and phone number.
- *Information that we collect automatically*
The App may collect certain information automatically from your device when you use it, such as information about the device or browser that you are accessing the App from or diagnostic data. In some countries, including countries in the European Economic Area ("EEA"), this information may be considered personal information under applicable data protection laws. The App may also collect information about how your device has interacted with the App, including the pages accessed and links clicked. Some of this information may be collected using cookies and similar tracking technologies. How CCH uses your personal information

CCH uses and processes or shares your personal information collected through the App for the following purposes:

- To deliver CCH's online programs, and to make you aware of CCH's face-to-face program offerings: We use your personal information so that we can connect with you directly and provide services related to our mission in an effective way.
- To send communications: We use your personal information to communicate with you about CCH, our services, programs, community news, and events we think may be of interest to you.
- To enable third party service providers and vendors who provide services, including data processing services, for the Organization, for example, Pushpay and MailChimp.
- To comply with legal obligations: We use your personal information as necessary when cooperating with law enforcement agencies, courts, and/or government authorities in accordance with our legal obligations under applicable laws.

Data security

CCH does not sell or rent your personal information to anyone. Except as noted above, CCH will restrict access to your personally identifiable information to employees who need access to your information in order to do their jobs. These employees are limited in number and are committed to our privacy policy.

We use appropriate technical and organisational measures to protect the personal information that we collect about you through the App. Further information regarding data security measures of our service provider for this app can be found on Pushpay's website at <https://pushpay.com/security>. Please be advised, however, that while we deploy these security measures and strive to protect your personal data, the use of the internet is not 100% secure, and for this reason we cannot guarantee the security or integrity of any personal data that you transmit or disclose to us online.

We retain your personal information for as long as we require it for the purposes set out in this Privacy Policy. However, we may also keep some of your personal information for a specified period of time as required by certain laws (for example to comply with applicable legal, tax or accounting requirements).
