

# Lesson #6: Independent Judiciary, Judicial Review, and the Rule of Law

## Activity 6.1: The Rule of Law



*The idea of the rule of law dates back to early civilizations, when some of the first laws were recorded on stone tablets and scrolls.*

The idea of the rule of law is one of the most important Constitutional principles in the United States. It is the foundation of what gives people the confidence to speak their minds and live their lives peacefully, as they know what the rules are in advance and know that all people will be held accountable to the same standards and expectations. Imagine that one of your friends changed the rules in the middle of a card game you were playing...you would be frustrated, and you would not want to play with that friend again! Our laws are stable, and the rules of the game cannot suddenly change. This gives people peace of mind and confidence in our government.

4. Below is a list examples of ways the Constitution and/or Bill of Rights ensures the rule of law is followed.
  - a. Laws may not single out \_\_\_\_\_ person. (Article I Section 9)
  - b. Government cannot suddenly declare an action \_\_\_\_\_ and then punish people who did it in the \_\_\_\_\_. (Article I Section 9)

6. How can individuals change or enact new laws if they believe changes are necessary?
7. Why is it important that there is a set of laws that are **above** the government?

## STEP 2: “Rule of Law” Points to Remember:<sup>3</sup>

- We are a nation of laws...not a nation of people.
- Everyone is treated fairly and equally under the same set of laws.
- The laws allow people to enjoy a peaceful existence with others.
- Our laws are based on the Constitution and protected by the courts.
- No one is above the law...no one is below the law.
- The “rule of law” is like the rules of the road...you must follow the laws to protect the safety of all.
- The “rule of law” is an agreement that everyone will play by the rules.
- We are governed by rules that are in the best interest of our country...not in the best interest of us personally.
- In America, we follow the “rule of law.” We do not serve men or women; we serve “The Law.”
