6. Q&A with Governor David Powers (UNC Board of Governors)

- *Longest serving member of the Board of Governors who is going into their final year of being on the board after 12 years.*
- *Governor Powers – Brief Remarks*
 - *There has been a lot of work done in regard to access and affordability, extremely happen to be able to have 4 NC Promise schools and maintain steady tuition universities*
 - *Trying to interact more with students across the system*
 - *Work on leadership profiles for the modern-day university, hosted 4 of the longest serving chancellors within the system to see the changes that a chancellor's role goes through, average time as a chancellor is around 5 ½ years, these chancellors have been around longer*
 - *Qualities that are becoming more important for institutional leaders include fundraising & marketing, more legislation interaction*
 - *Planning on visiting institutions to see what students believe chancellors need to do/have*

UNC-A– What is the process for an institution to become a NC Promise school?

Governor Powers - *BOG can recommend schools, but it is up to the legislature. Calculations need to be done for the university and there is an average 15-18 MIL cost to the institution. Conversation has begun around WSSM & UNCA to become NC Promise schools, currently reaching out to local legislators to advocate in Raleigh and also utilizing the Chancellor Search to work towards to find someone to advocate for this within the system. The most difficulty comes with financing with the Out-Of-State piece of the NC Promise. There is consistent conversation surrounding it*

ASU - How do we (UNC System) help ensure that Chancellor's aren't heavily influenced by other Higher Educations professionals while in their roles?

Governor Powers – *It is difficult to just drop friends or mentors you've made throughout your career. Many chancellors come from within academia & must set themselves apart from others to get these roles. It can be difficult to make that separation. Chancellors must be aware that their priorities are the students, faculty, staff & alumni/donors of the institution*

NCSU – Has there been more discussion on how the Campus Security Fee can be allocated to mental health?

Governor Powers – *When first instituted it was to help pay campus police departments and to help hire and retain personnel. ASG really helped bring to more attention and focus on mental health. Allocating money to mental health and balancing it with affordability is always a discussion.*

UNC-CH – What statistics could be helpful to provide BOG about graduate student education?

Governor Powers- *A lot of focuses are on undergrad students, but there is still a large portion of graduate students within the system. Looking on collection of retention, graduation rates, entry rates, placement rates etc. seeing graduate students progress throughout their education. Where do they go? Most misleading stat is starting pay, many differences throughout the various careers.*

Getting students out into the world. More resources in tracking students in where they go after graduation and studying trends.

NCA&T – *Out of State enrollment fine placed on NCA&T in 2021 and that effect on students?*

Governor Powers – *I am a large advocate of the increasing of OOS cap. The school didn't serve any less in-state students than out-of-state students. The policy states a violation for 2 years in the row results in a fine. Generally, not a fan, policy should be changed & for many schools the cap has been raised. There is a strong demand in OOS students wanting to come to NC. It's good that we serve in-state students, but the cap should increase. It is likely that the policy will be looked at in the long term.*

NCA&T - *How does the fine vary between schools*

Governor Powers - *Not sure, it is possibly a percentage of the excess tuition brought in from Out-Of-State students*

NCSSM – *How does the UNC BOG plan to support system initiatives in regard to sustainability, there is a great opportunity with renovation projects within institutions to emphasize sustainability.*

Governor Powers - *Master's Program proposal for Sustainability Science – demand for people with expertise with sustainability in many companies, in many construction contracts there are sustainability clauses & BOG has been supportive in curriculum and construction additives for sustainability. Trying to keep up to date in the focus of the issue.*

ECU – *I am curious to see what are key points in university leadership the BOG wants to see?*

Governor Powers - *Every school is different, and the right candidate differs between the schools. There are longevity issues with some schools as leadership ages. The development of CORE common traits are skills that every leader will need as things emerge ability to deal with politics, fundraising, marketing, the ability to tell the institutions story. The job has changed a lot over the years, and we are looking to build the skillset needed overall, but also be able to make sure that institutions are able to find their best fit.*

ASU – How does the Board plan to address campuses accepting more students than it is capable to house?

Governor Powers – There is difficulty with expanding, depending on the campus the terrain can be difficult. All schools should have a growth mentality, but not just with numbers. Capacity growth can be limited, because of the money needed for dorms & other resources. Example is the handling of power i.e WCU's steam plant near falling apart and is now just renovated. Growth can also mean growth in programs & partnerships. There are various ways to grow that don't just involve admitting more students.

UNC-CH– There is food insecurity at many campuses, is BOG is watching the issue and what information can individual institutions provide?

Governor Powers - It's something on President Han's mind, especially as it is becoming a much more apparent issue across the UNC system. Will ask to make sure that we are working with campuses to get more information at the individual level.

Q&A w/ Carsen Schaeffer & Jennifer Pages from UNC-C Niner Finances

NCA&T - Do you provide counsel on how to be financially literate in regards to credit cards and financial aid in order to put students on track to begin their finance journey?

Jennifer Pages: *A lot of students come in and ask about FAFSA and that gets them asking about more that we offer. A large conversation right now is scholarships & how to use them, building overall knowledge on financial literacy.*

Carsen Schaeffer: *Students in intake typically come in for just 1 question, but there are a lot of topics/questions that we can cover, which are build-upon topics.*

UNC-G – What thoughts are there on expansion?

Carsen Schaeffer: *With the hopes of more funding, there are areas for expansion in regard to the staffing, website, modules, campus outreach and increasing awareness overall on campus.*

Jennifer Pages: *There are goals on reaching freshman & transfer-students before they even reach the campus through orientation and other means*

Carsen Schaeffer: Higher administration would like to have Financial Literacy as a required course for first-year students as there is an increasing need for students to learn about finances

UNC-W – What does training look like over a semester?

Jennifer Pages Training is primarily on canvas with meetings with other officers. Students also sit in on 1:1 appointments and work on practicing them. There is a lot of practicing of the presentation and process.

Carsen Schaeffer: Sometimes students will do more research for more specific things, i.e medical school loans, which not everyone knows about.

NCSU – How does talking about financial literacy to administration differ from a smaller scale?

Carsen Schaeffer: There is a difference of importance/perspective, with higher education staff it is creating opportunities for students, and it's been becoming an increasing topic within higher education overall and there is generally more support amongst the staff. The presentation was more about the creation & impact of the program versus the actual teaching of the program.

ECSU – What is the set-up of canvas modules?

Carsen Schaeffer: Students can choose any topic they want to learn about, but niche topics require more research

Nicole: In regard to training, there are overall modules that they have to learn about but peer ambassadors can go into more niche topics.

Largely calm conversations, kicking off e-board review process, distribution of the form coming soon to the e-board. Review of responses & meeting 1:1 with the e-board and provide the feed back to SBP + SBVP, spent time in subcommittees to review and create legislation

- *Aryan Talati, VP of Budget and Finance*

Looking at legislation to review in January alongside Campus Outreach, approved addition 1,500 to Campus Outreach for additional help. Looking at revisiting how B&F bills are looked in GA, possibly looking at 2 readings versus 3 and looking for ways to streamline small amounts. Will be working with the internal operations committee to see if anyone would want to sponsor a bill. Looking at the grant process, a lot of applications already, 8/9 applications within this cycle, approved. Granted 2,480 to orgs from NCSU & UNC-CH. Looking over the ledger, as it currently stands.

- *Eelya Sefat, VP of Government Outreach*

Very informative meeting, clearing up what past, future BOG meetings are going to look like and seeing how the GA after midterms looks like. Priorities, enrollment & funding, fac. Staff compensation, and managing real estate portfolio within the system and across the system. Ways to improve outreach and communication with the BOG/GA. Finding ways to implement a report from ASG to the GA and seeing the proper way to do that.

- *Kennedy Reid, VP of Campus Outreach*

Icebreakers & informative meeting, working to rejuvenate for the spring. Met November 10th, discussed spring initiative regarding budget. \$17, 500 scholarships to students who are dedicated to serving their campus, waiting to share the name, working on an application process, survey review almost 100 responses to the ASG, break out rooms on specific topics, smaller action plans and will be working on getting legislation drafted, looking at how spring will look like and how individual campus action planning will look like.

- *Cameron Brown, VP of Media Outreach*

Pell Grant initiative form will be going out Monday, wanting to make sure it represents all students, wants to get legislation that UNC ASG recognizes the need for the Pell Grant within the UNC system, as it's needed for many students at different institutions to get an education.
