## 1. Police Report

There was a Rural operation we ran on the 24<sup>th</sup> May 2024 which involved Wellington West and Rural SNT, Wellington North SNT, Specials, the Business and Rural crime officers and a Roads Policing unit. Covered all the rural area's during the evening to about 0100hrs. Had several stop searches, a couple of traffic offences reported and one arrest for drink driving. Lots of engagement with farmers. There was also speed enforcement conducted during the day on the A442 near Waters Upton and an engagement van at the new Allscott Meads estate.

Our new PCSO Josh PEEL has now started and is a great asset to the team especially as he is local to the area and has a background in farming.

Ivan now has use of the 4x4 as a rural vehicle for rural patrolling.

Rural crime appears to show a recent trend away from farms and towards Severn Trent sites being targeted in the last few weeks along with building sites. Fortunately, not in this Parish area. We will be targeting the suspects involved in this.

Three of the main suspects involved in the rural thefts are now on remand and are facing various court dates, with other suspects, between now and December.

In terms of offences, we have had a theft from a farm nearby at Waters Upton on the 06/05/24, antisocial behaviour with a car driving around the Village Hall car park on the 20/05/24. The driver of the vehicle was spoken to by police.
