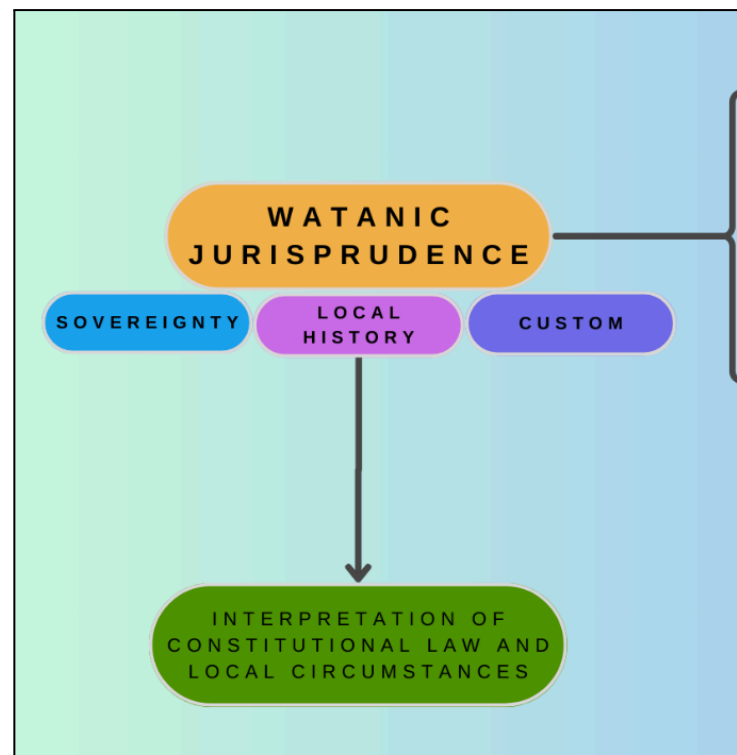

According to the draft, terrorism is defined as:

“...all criminal acts directed against a State and intended or circulated to create a state of terror in the minds of particular persons or organisation of persons or the general public”.

Even though the convention had never come into existence, this definition was used as a guide in subsequent discussions on terrorism at the UN (Rupérez, 2007).

The method illustrated by watanic jurisprudence is supported by the Federal Court in the case of *Indira Gandhi A/P. Mutho v. Director of Perak Islamic Religious Department & Ors and other appeals* [2018] 1 MLJ 545 when the Federal Court adopts the constitutional method of interpretation by the Supreme Court of Canada as follows:
