


## THE REAL NAPOLEON III—nephew of Napoleon I

According to studies by Gérard Lucotte and his coauthors based on DNA research since 2011, Napoleon Bonaparte belonged to Y-DNA haplogroup E1b1b1c1\* (E-M34\*)

This haplogroup, rare in Europe, has its highest concentration in Ethiopia and Somalia...

The said NAPOLEON BONAPARTE, alias Jaffa Bonaparte, alias Opium Bonaparte, alias Whitworth Bonaparte, alias Acre Bonaparte, is a Corsican by birth, about five feet four inches in height, of a swarthy black complexion, dark hair and eye brows, and resembles a great deal in person, a Bear-leader, or one of the Savoyards who play on the reeds at Vauxhall:

**schwarz**, I. a. (comp. **schwarz'zer**; sup. **schwarz'gest**) **black**; (**schwarzbraun**) **swarthy**  
II. a. I. a) **der Schäe**, **black man**, **negro**; fam. **nigger**, **blackie**; **die Schäe**, **swart** (adj.)

Old English *swart* "black, dark," of night, clouds, also figurative, "wicked, infamous," from Proto-Germanic *\*swarta-* (source also of Old Frisian, Old Saxon, and Middle Dutch *swart*, Dutch *zwart*, Old Norse *svartr*, German *schwarz*, Gothic *swarts* "dark-colored, black"), from PIE root *\*sworudo-* "dirty, dark, black" (source of *sordid*). The true Germanic word, surviving in the Continental languages but displaced in English by **black**. Of skin color of persons from late 14c. Related: *Swarlest*.



The word Swarthy or Swart derives from 'Schwarz' or 'Schwartz' which means "to be black; black man, and negro

Napoleon III was the first President of France (as Louis-Napoléon Bonaparte) from 1848 to 1852 and the last monarch of France as Emperor of the French from 1852 to 1870...

A nephew of Napoleon I, he was the last monarch to rule over France...

Elected to the presidency of the Second Republic in 1848, he seized power by force in 1851, when he could not constitutionally be reelected; he later proclaimed himself Emperor of the French...

He founded the Second Empire, reigning until the defeat of the French Army and his capture by Prussia and its allies at the Battle of Sedan in 1870...

Napoleon III was a popular monarch, who oversaw the modernization of the French economy and filled Paris with new boulevards and parks...



He expanded the French overseas empire and made the French merchant navy the second largest in the world, engaged in the Second Italian War of Independence as well as the disastrous Franco-Prussian War, in which he commanded his soldiers during the fight and was captured...

This man is now erroneously and ridiculously identified as "Radama II" king of Madagascar...

The Colony of Madagascar and Dependencies was a French colony off the coast of Southeast Africa...

However, there are absolutely no firsthand or primary historical accounts that make any reference to a “Radama II”

A pseudonym or alias is a fictitious name that a person or group assumes for a particular purpose...

In this case—a fictitious name that a group assigned to a person for a particular purpose...

For one, the II, in “Radama II” is what’s known as Regnal numbers—which are ordinal numbers used to distinguish among persons with the same name who held the same office...



Most importantly, they are used to distinguish monarchs...

An ordinal is the number placed after a monarch's regnal name to differentiate between a number of kings, queens or princes reigning the same territory with the same regnal name...

Almost all West European monarchs, after medieval times have used ordinals...

Ordinals were a European creation...

Ordinals are not a thing in Malagasy or indigenous Austronesian society and culture...

No tribal Chief in all of New Guinea, Melanesia, Polynesia or Southeast Asia, has ordinal numbers after their name...

For two, we're told that "Radama II" was a member of the Merina and of the Merina Kingdom...

The Merina Kingdom was allegedly founded in 1540 by "Andriamanelo" yet there are absolutely no firsthand or primary historical records that can attest to this...

The so called monarchs of the so called Merina Kingdom have no documented or recorded history—they have no contemporaries to tell their story—all of the so called history that we do have on record of them, is said to have come from "oral tradition"—but who the people are that passed on this oral tradition nobody knows...

"Radama II" just popped up out of nowhere in the mid 1800's, wearing high European fashion, and posing with European crowns and scepters...

An indigenous Malagasy king from a pre colonial kingdom in Madagascar wouldn't use regnal numbers after his name, pre colonial indigenous Malagasy men did not wear European military fashion, European royal crowns, nor did they sit on European royal thrones...
