(Retention Ponds)

Unmanned aerial systems may be utilized to enhance the department's mission of protecting lives and property when other means and resources are not available or are less effective. Any use of a UAS will be in strict accordance with constitutional and privacy rights and Federal Aviation Administration (FAA) regulations.

<u>Unmanned Aerial System (UAS / sUAS / UAV / Drone)</u> - An unmanned aircraft of any type that is capable of sustaining directed flight, whether pre programmed or remotely controlled (commonly referred to as an unmanned aerial vehicle (UAV)), and all of the supporting or attached systems designed for gathering information through imaging, recording, or any other means.

The use of Unmanned Aircraft Systems (sUAS) in the United States National Airspace System (NAS) is governed by the Federal Aviation Administration (FAA) under **Title 14 of the Code of Federal Regulations** (CFR), Part 107 (14 CFR §§ 107.1–107.205). This regulation outlines operational limitations, pilot certification requirements, airspace authorization procedures, and safety standards for the commercial and governmental use of drones weighing less than 55 pounds. All UAS operations must comply with Part 107 unless specifically exempted or authorized under a waiver.

The use of Unmanned Aircraft Systems (UAS) by law enforcement agencies in the State of Illinois is governed by the **Freedom from Drone Surveillance Act** (725 ILCS 167/I) and the **Drones as First Responders Act** (PA 103-0101).

Cherry Valley Police Department **Policy 606 - Unmanned Aerial System** governs the use of unmanned aircraft systems (UAS) by the department.
