Yes this is moving away from the original topic, but I think it is an important issue - the layout and content in the wiki about English parishes.

I believe that the original content for the Research Wiki was taken from the FHL resource guides and this has had an influence on how later information in the wiki has been presented. I have set-up a <u>WikiProject English parishes</u> where issues like the one you raise can be addressed. I am more a technologist than an experienced genealogist. I'm confident about getting this done in the wiki, but unsure about the best direction.

Input from people like yourself with a British worldview and understanding of local resources is what is needed. No the wiki should not only cater for a North American audience, but it will reflect the understanding of those that contribute. Only as more UK based users get involved will we be able to steer the wiki away from it's beginnings as an extension of the knowledge of FHL staff.

Could someone please review the Census page for Herefordshire which has been created in non-alphabetical order and omits parishes which can be found to have been microfilmed? Contributors are at present disregarding it and providing parish records link in the page heading "Church Records". It does appear that the Family History Library view differs markedly from English genealogists practice. This is based on a microfilm holding rather than the finding aids in use either online or in archives; similarly there are discrepancies in the film headings and subsequently the catalogue entry which Familysearch uses which have increasingly been overcome in online source citations by commercial online providers.

Yorkshire Census

In common with other English counties the page which exists contains many broken links and mystery items and is dysfunctional.

The page creations for Yorkshire contain headings for church records and this appears to be where the entries for census records lie within the often inaccurate catalogue entry for the Family History Library film holdings.

There is a further problem in that the wiki page creator has created parish names in reverse due to unfamiliarity with the geography of the county in addition to the errors on the use of prefixes of "Great" "Little" "Old" "New" resulting in some fanciful and mythical place names. The search in wiki is also variable and it is possible to search for a parish and return no result; create a page and then return to it in search only to discover a page had been created previously.

The pre 1851 only page creation is problematic for a number of counties which contain post 1851 church and chapel building. This is particularly problematic in coal field communities which expanded and built places of worship which have since contracted. It seems odd to have created prescriptive wiki pages with invitations to contribute based on an American catalogue of partial filming of Anglican records when the Family History Library has a large holding of non-conformist records for many villages and civil parishes in the county. The additional problem is the removal of invitation to contribute by contributors who are adding copyright text from British History Online and A Vision of Britain both of which claim copyright material on text.

In several cases the contributor has added text for common village names in the county without differentiating between the correct Anglican parish within the civil parish suggesting again an unfamiliarity with the geography and history of the county.

Use of Anglican parish as a locator is less reliable than use of civil parish which is widely used in English catalogues for records and will be found to be the Wikipedia basis for county material.
