1. What is the name and geographical reach of your proposed program? Regional, County, or City?
2. Is your community listed on an environmental justice list or is your community economically disadvantaged? Use the Cal EnviroScreen tool to determine if your municipality falls in this category and please provide the [CalEnviroScreen Score](#) (for example: 96-100%).
3. Please list the stakeholders (agencies and individuals) you have involved in the early design of your program in the following categories: Pollution Prevention, Materials Management/Recycling, Energy Conservation, Wastewater/Stormwater and Water-Use Efficiency.
4. What type of direct funding will be used for your program and how much? (Will your jurisdiction dedicate additional funding to maintain the program. This could be through grants to businesses, etc.)
5. What type and how much leveraged funding will be used, such as in-kind staff time?
6. Do you agree to use the California Green Business Database (GreenBizTracker) to collect the data necessary to track metrics?
7. Will you ensure that businesses certified by your agency are in compliance with regulatory laws and meet the essential criteria set forth by the California Green Business Network to ensure statewide consistency?
8. Members are provided opportunities to connect with other programs (such as webinars and online knowledge-base sharing as well as an annual conference). Do you anticipate a member of your program will be able to participate in Network activities?
