Chronology of Early Coastal NC Hendersons The Albemarle Sound Hendersons

Includes Hendersons of all counties comprising original Albemarle Precinct who cannot be conclusively connected to known Henderson ancestors in Virginia or Maryland

I am calling this collection of unidentified and/or ungrouped Hendersons the *Albemarle Sound Hendersons* since they appear at various times and in various places within the boundaries of <u>old Albemarle Precinct</u> (an original Carolina precinct which encompassed a <u>shifting mass of counties</u> surrounding the sound, southwards to the Cape Fear). This does <u>not</u> include records of Hendersons known to belong to the Onslow County NC group (<u>see chronology</u>) who originated from the Hendersons of the early Delmarva Peninsula (<u>see chronology</u>), however some of the records currently on this document may later be proven to connect to those groups, or to the Hendersons of Virginia's Tidewater, and the records in question may be moved accordingly. The general location of the men mentioned in the records below have, for the most part, been plotted on <u>this map</u> with corresponding details.

1701 Nov 7

Albemarle Pct NC

Note: Albemarle was formed in 1664 and "although growth was slow, settlers trickled in from Virginia." Early Chowan/Bertie records contain a number of names from neighboring Nansemond County VA (just to the north). Albemarle County ceased to function as a governmental until in 1689 so it is difficult to tell which modern-day county this record would fall into.

Note: There was a <u>Francis Parrott</u> in Maryland in 1655 and 1658, and another transported himself to Maryland in 1662. There were also prominent Parrotts in Middlesex Co VA. <u>Nathaniel Chevin</u> was a friend of Thomas Pollock and a justice and council member in Chowan Pct. He had a falling-out with Governor Eden that put him out of favor and he died in 1720.

Gilbert Henderson (of Northampton Co VA) had descendents who married into the Green family, and a James Henderson witnessed the 1765 Bladen Co will of William Hall along with "A. Green" and "Mary Green."

Note: The George Henderson is probably the Scottish nephew of Captain David Henderson. He may not have technically been a resident of NC so that may account for his name being struck through on the list, although the notation after was illegible. I know of no other contemporaneous George Hendersons, so this is my best guess, but it does place George in North Carolina earlier/longer than I had assumed he'd been there. The James Henderson is likely the same one mentioned in Eden's 1721 will and also the land sale in 1737 in Bertie to Nicholas Hunter. I can't account for the Henry Henderson. The only other early mid-Atlantic Henry Henderson I'm aware of owned land on the York River and died in 1673, writing a will while in England that named wife Susanna, but no Henderson heirs.

(No proof of the rumored marriage to a local planter's daughter has been found.) By the end of August, however, Teach was back to his old ways and had violated his pardon. *From Wikipedia*

1718 July 10 Virginia

Contextual History: Concerned that some of Blackbeard's former crew had appeared in Virginia seaports, Governor Alexander Spotswood <u>issues a proclamation</u> "requiring all former pirates to make themselves known to authorities, to give up their arms, and to not travel in groups larger than three." Overstepping the bounds of his authority, he arrests William Howard, Blackbeard's former quartermaster, prompting a defense (on the grounds of wrongful arrest) by prominent Williamsburg attorney John Holloway -- a close friend of Governor Eden who will be named along with a James Henderson and three other "friends" in Eden's 1721 will. Spotswood was disgruntled by Holloway's actions and fell out with him over the William Howard affair.

Contraband goods from the pirate's ship were also found stored in Knight's barn. Some members of Blackbeard's crew testified that Knight had been aboard Blackbeard's ship and that the secretary had accepted gifts from them at his home. The entire affair proved highly embarrassing to Governor Eden, who was "heavily criticised" for his involvement with Teach. *From Wikipedia*

From what I can tell, Captain David died without direct heirs and left his estate to his nieces and nephews. He must have had at least one brother at some point (father of nephew George Henderson), but possibly no other siblings (or at least those with children) since he only names those of his sister in addition to George. George Henderson would reportedly attempt to "get the whole of the estate" from his cousins, for which they brought suit against him, however, he would die only about a year after his uncle, leaving his portion of Captain David's estate to members of the Nelson, Moore and Scott families (relationships, if any, unidentified).

Note the occurrence of the names Moore and Bond, both names were witnesses to James "Isaac" Henderson's 1770 Onslow County will. Benjamin Hill (b 1637 m Miss Latham? Laman?) was of Lazy Hill in Bertie Co NC. There is a paragraph of footnotes in The NC Historical and Genealogical register that <u>outlines Hill's family members</u>, but there is no connection with any Henderson apparent in this information. If Benj Hill's dob is correct, this is likely a son or grandson).

At first glance I thought this was Judge Richard Henderson of Hanover Co VA and Granville Co NC, but a double-check of that gentleman's birth and death dates (1734-1785) reveals that it must be another. The early Hanover Henderson line of VA is currently supposed to have consisted of Samuel, Nathaniel, Richard, and Edward, (but that has not yet been proven, according to a Hanover researcher with whom I communicate). Samuel and Nathaniel moved to Granville Co NC in the 1740-50 time period (Samuel was father of Judge Richard Henderson of Transylvania project). Notice that this Richard is found in conjunction with the same names of prominent NC colonial officials as are James Henderson and Captain David Henderson. This implies to me that this group of Bertie & Chowan Hendersons may have been men of means and status, although I have not found very many specific references to them in old records, so they do not appear to have been as consistently active in the community or government to any degree appraoching the other gentlemen named. Perhaps they were property owners elsewhere and were in Carolina on business.

Notice that Alexander Gallatly carried certificates for James Henderson and others to "leave the country" in 1777 (see below) when Henderson, a Loyalist, refused to swear an oath to the new government during the revolution.

1776-1782

[Mr. Alexander Gelatly] "carries certificates from the Clerk of this County for John Weir, Alexander Clarke, William Knight (former Comptroller of the Customs at Port Roanoke), James McClain and John Baggs, and JAMES HENDERSON, who were all cited last Court to take the oath. They chose rather to leave the Country than to do so. They, some of them did not come under the Act of Assembly I believe, and considered themselves pointed at. They are all men who have supported very fair characters, have ever been peaceful citizens, and borne their share of all public duties assigned them, but refused the oath of Government, and therefore entered into a recognizance to leave the Country agreeable to Act of Assembly -- the time's near out, and they wait on your Excellency for your permission that they may depart the country...Any thing your Excellency can do consistent with the line of your duty to facilitate the departure of him and the others on whose behalf he appears would be conferring a favor on your Excellency's most obed. & very Hble serv't., Robert Smith" Letter to Governor Caswell from Robert Smith

It is difficult to know if the James Henderson in Edenton (with John and William) was the same James Henderson mentioned in Governor Charles Eden's 1721 will. It seems unlikely as I would have expected the James Henderson of 1721 to have been roughly of an age with 41-yo Charles Eden and his contemporaries mentioned in the will. I would place the Bertie County James Henderson's birth date no later than 1700 at the outside, which would have made him 77 years old in 1777 (when the James Henderson above was fleeing the Carolinas), and unlikely to be taking flight with loyalists.

On the other hand, an older man who had been close to officers of colonial government may have had strong loyalties to the crown, so it is not out of the question that they could be the same. My guess, however, is that the Hendersons we find in and around Bertie County late 1700's are brothers or cousins, sons or grandsons of the earlier Albemarle, Chowan & Bertie Hendersons above.

Our James "Isaac" Henderson of Onslow County made his will there on October 20, 1770. Although we do not know when the will was proved, it seems likely that our James had passed away before 1777, more circumstantial evidence that he is not the same James awaiting a certificate of departure to be the same who was fleeing the state in 1777.

In Robert O. DeMond's "The Loyalists in North Carolina During the Revolution" (Chapter 9, pp181-184) we find an account of the exodus of Tories from North Carolina as the revolution got underway: "The first act of banishment against the Loyalists was passed in April, 1777...Those who decided to leave were for the most part prominent in the economic and political life of the state...In January, 1778 Governor Josiah Martin, who was in New York City, reported that in the last six months not less than one hundred and fifty refugees had arrived from North Carolina...New YorK City, being in the hands of the British, appears to have been the destination of a large number of North Carolinians at this time. In July, 1777 the North Carolina Gazette announced that a large vessel had sailed from New Bern with a great number of Tories, their wives and families, mostly Scotch. They were described as men of property, which for the most part they removed with them....Josiah Martin, the former governor of North Carolina, who was in New York at this time, described the arrival of the vessel...He reported that two vessels had arrived from North Carolina within six weeks which contained besides women, children and Negroes, twenty-two refugee Loyalist subjects from North Carolina, all but three of whom were natives from Scotland...Another prominent North Carolina refugee in New York at this time was William Knight, former Comptroller of the Customs at Port Roanoke...The rest of the recent arrivals were described as merchants or mechanics, all of whom had been loyal from the beginning except George Miller and [?] Maxwell, who after bearing arms in rebellion, repented and refused to abjure their sovereign. Only one of the group was a native of North Carolina, and he was Brice...Regardless of character and conduct, all were required to leave who did not take the oath. Robert Smith interceded with Governor Caswell to

facilitate the departure of Alexander Gelately, former register at Edenton, whom he described as a gentleman of high ideals. John Weir, Alexander Clarke, William Knight, James McClain, John Baggs and <u>James Henderson</u>, who were also included in the request, were described as men of the finest character..."

DeMond states that "The eastern counties of [North Carolina] were well represented in the migrations at this time. One of the most common methods of departure from these counties was for a group of men to purchase a ship, load it with such goods as they might be permitted to take, and set out for the West Indies."
