Information You Provide to Us

We collect information you provide directly to us. For example, we collect information when you fill out a form, communicate with us via third party social media sites, request customer support, or otherwise communicate with us. The types of information we may collect include your name, email address, phone number, and any other information you choose to provide.

Automatically Collected Information

When you access or use our Services, we automatically collect information about you, including:
