## **EXECUTIVE SESSION**

	By roll call vote the Hurley R-I Board of education will enter into closed session pursuant to RSMO 610.021 to discuss the following.
1	. Legal actions, causes of action or litigation involving a public governmental body and confidential or privileged communications between a public governmental body or its representatives and its attorneys.
2	. Leasing, purchase or sale of real estate by a public governmental body where public knowledge of the transaction might adversely affect the legal consideration thereof.
_X3	3. Hiring, firing, disciplining or promoting of particular employees by a public government body when personal information about the employee is discussed or recorded.
4	. Non-judicial mental or physical health proceedings involving identifiable persons, including medical, psychiatric, psychological, or alcoholism or drug dependency diagnosis or treatment.
5	. Scholastic probation, expulsion or graduation of identifiable individuals, including records of individual tests of examination scores.
6	. Testing and examination materials, before the test or examination, is given.
7	. Welfare cases of identifiable individuals.
8	. Preparation, including any discussions or work product for negotiations with employee groups.
9	. Software codes for electronic data processing.
1	0. Specifications for competitive bidding.
1	1. Sealed bids and related documents.
1	2. Individually identifiable personal records.
1	3. Records which are protected from disclosure by law.
1	4. Scientific and technological innovations in which the owner has proprietary interests.
1	5. Records relating to municipal hotlines established for the reporting of abuse and wrongdoing.
1	6. Confidential privileged communications between a public governmental body and its auditor.
1	7. Operational guidelines to protect the health or safety of persons.
1	8. Security systems and structural plans where disclosure would threaten public safety.
1	9. Records that identify security systems and access codes.
2	0. Records that identify and would allow unauthorized access to data systems.
2	1. Credit card numbers, personal identification numbers, digital certificates, keys and codes to protect security.
