Impact of Decision

Next Steps:

If approved by the Legislative Council, the referendum question will be forwarded to Elections SSMU to be included in the Winter 2025 Referendum.

Motion or Resolution for Approval

Be it resolved that the Legislative Council approve the following question for the Winter 2025 referendum period:

“Do you agree to the renewal of the opt-outable TVM Fee at \$1.50 per semester for full-time and part-time students, beginning in Fall 2025 and ending in Winter 2030 (inclusive and excluding the Summer semester), with the understanding that a majority ‘no’ vote will result in the discontinuation of the fee?”
