- Following the daily challenge checklist and content framework
- Attending scheduled live coaching calls (or watching replays within the required timeframe, if replay access is provided)
- Remaining active in the community space
- Completing assigned mindset, identity, and execution challenges
- Submitting any required progress tracking or proof of work

Failure to meet these requirements may result in ineligibility for refunds, bonuses, or continued participation.

6. Content & Growth Guidelines

To ensure fairness and integrity of results, participants may **not**:

- Purchase followers, engagement, or views
- Use bots, automation, or artificial growth tools
- Run paid ads or promotions to artificially inflate results
- Misrepresent performance data

All growth must be organic and aligned with the Program strategy. Violation may result in immediate removal without refund.

7. Performance-Based Refund Policy
