Identification of Impacted Students:

The DTL, BLT, and TBT's will identify the learning loss of all at-risk students by analyzing district reading and math benchmark data and Brightbytes survey data.

Identification of Student Needs:

Individual student instructional needs will be determined based on district benchmark data, survey data, and attendance data. Students in need of Tier 2 and 3 support will be provided targeted interventions. The buildings' Response to Intervention teams will monitor progress and adjust interventions when needed or if appropriate.

Resources and Budget:

This plan will be supported by local, state, and federal funding including Title I, II, III, IV, ESSER, General and Student Wellness and Success Funds.

Extended Learning Plan:

Elementary:

- ➤ All K-5 students will have access to online digital resources (iReady Reading and Math) and devices over the summer
- > Districtwide Cool Cats Summer School (reading and math intervention for Tier 1 & 2 students)
- > Extended School Year Summer School (reading and math intervention for Tier 3 students)
- ➤ Additional temporary staff members (11) will be assigned to each building to provide targeted interventions for at-risk students (ARP ESSER)
- > Crossroads counselors in each elementary school will provide social-emotional support for students
- ➤ An additional full-time intervention specialist will be added to support Mentor Schools Online students(21-22 school year)
- > Elementary students will participate in Responsive Classroom activities during daily meetings

Middle School:

- ➤ Three additional temporary staff members (6 total) will be assigned to each middle school to provide targeted reading and math interventions during the 2021-2022 and 2022-2023 school years. (ARP ESSER)
- Credit recovery summer school will be provided for 7th and 8th-grade students who failed core courses.
- ➤ All 6-8 grade students will have access to online differentiated reading and math programs and devices over the summer (Summer 2021& 2022). Tier 2 and 3 students will be monitored by reading (3) and math (3) success coaches (Summer 2021 ARP ESSER)
- → 6-8 Reading and Math Summer School will be offered for at-risk students (Summer 2022 ARP ESSER)
- > Crossroads counselors in both buildings will provide social-emotional support for students
- > Student tutoring services are available at the ESC of the Western Reserve
- > An additional full-time intervention specialist will be added to support Mentor Schools Online students (2021-2022 only)
