Motion No. 734

Title: Motion to Create a 100@25 Club Affiliate Referral Program

Mover: Hector Roos

Motion: The Fundraising Committee moves this motion before this honorable Executive Committee to create a county affiliate referral program that makes a referral payment for a new recurring donor in that county to the 100@25 Club as follows:

- County affiliates where a recurring donor is located will receive a referral payment of \$25 after the recurring donor's 4th consecutive payment into the 100@25 Club.
- The LPF treasurer will disburse corresponding payments every 6 months to qualifying county affiliates.
- Expenditures are to be limited to \$2,000 annually unless further funds are authorized by the
 Executive Committee.
- Program applies for new recurring donors who join on or after January 1, 2022.
- For an affiliate to participate in this program, they must request a unique referral link to invite recurring donors to.
- One referral payment per qualified recurring donor of at least \$25 per month who has not been a recurring donor of at least \$25 per month within one year of their join date.

Discussion: A simple referral program with county affiliates who recruit new members of the 100@25 Club. This is meant to incentivize county affiliates to integrate 100@25 Club activities such as club event announcements and "pin" presentations to club members present.

Title: Motion to Approve Contract for Merchandizing Dropshipper

Mover: Hector Roos

Motion: I move to approve a service agreement with Spreadshop dropshipping service to provide a

commercial solution for merchandising on the LPF website. https://www.spreadshop.com.

Statement of Need:

Part of Chairman Nekhaila's vision deck includes the implementation of an LPF store. The decision was made

to follow the LP.org model by setting up a hyperlink which currently exists on LPF.org called "Shop" under the

"Get Involved" dropdown menu. The hyperlink opens to a new page that will be a branded version of the

Spreadshop store (it currently does not work). This service resolves the need of a "merchandise" solution at

no risk which we can be added to or easily replaced.

Spreadshop service agreement terms include:

- No cost to start (no upfront costs)
- · Only expense is at purchase
- · Turn it on and off whenever you want
- Monthly payout
- · We set product price and set profit margin

Spreadshop features include:

- Easy to set up e-commerce page (including the inclusion of any disclaimer text)
- No inventory
- Over 200 products (but only apparel and accessories)
- "Whitelabel" Spreadshirt quality
- Integration with social media platforms

B. Motion No. 728

Title: Motion to Approve \$140 Plus \$70 per Ticket Sold in Expenditures for the 2021 VIP Luncheon Prior to the LPF Holiday Party

Mover: Josh Hlavka (on Behalf of Developmental Director Celicia Slafter)

Motion: I move to approve \$140 plus \$70 per ticket sold in expenditures for the VIP Luncheon prior to the LPF Holiday Party scheduled for Saturday, December 11th, 2021. The VIP Luncheon will be held at the Beach House Pompano. https://beachhousepompano.com/ at 270 North Pompano Beach Blvd in Pompano, FL.

The VIP Luncheon is additional to the LPF Holiday Party and was planned after the main motion for funds approval was granted. This was done with the mindset that any VIP tickets sold will more than pay for the spending on lunches.

After reviewing event package options with the restaurant, it is determined that the best course of action is not to contract with them for an event, which would incur a contractual food and beverage minimum. We will do a walk-in that day. Hector Roos will be present at the Beach House Pompano 30 minutes prior to Noon to reserve the table and request that the host restrict the menus to the brunch menu.

The VIP Luncheon is meant to attract the higher spending members of the party with the exclusive opportunity to spend more intimate time with our Guest Speaker and our Special Guest.

The Guest Speaker and Special Guest lunches will be comped, and have already been covered by the other tickets we have sold.

VIP Luncheon tickets are priced at \$195. We have currently sold 5 tickets for the VIP Luncheon.

The average individual meal cost is expected to be \$50. \$20 per meal is added to cover gratuity and taxes.

With 5 tickets sold, spending will be \$140 for the Guest Speaker and Special Guest meals plus \$350 for the 5 tickets sold, for a total of \$490 in spending for VIP Lunches.

At the current number of tickets sold (5), the party will profit \$485 for the VIP Luncheon.

For every VIP Luncheon ticket sold from this point, the party will profit \$125.

These calculations of profit do not include consideration for costs of the rest of the Holiday Party, even though VIP ticket holders get access, because the approved expenses for the LPF Holiday Party have already been covered more than twice over in Presenting and other sponsorships.

Title: Motion to Disaffiliate Hillsborough County

Motion: I move to formally disaffiliate Hillsborough County and begin the process of securing all LPF assets

until the county is able to reaffiliate per our Bylaws.

Disaffiliation is pursued through Article I Sections 4 and 8 of the LPF Bylaws as posted on the LPF.org Docs

Site. Reasons for disaffiliation is as follows:

- As of the Hillsborough County annual meeting in March 2021, new officers were elected to the executive

committee, one of which was not a credentialed member of the LPF and was indicated as such by the

Secretary.

- Previous officers had indicated in advance that they would be stepping down, citing personal obligations

and a desire to pass the torch.

- A meeting was held, with proper notice, for the purpose of electing new officers to the executive

committee in August in an attempt to rectify the deficiency, unfortunately, a member that was elected was

still not a member of the LPF as recognized by the LPF Secretary per our credentialing requirements.

- Given the lack of a proper hand-over of Hillsborough County Affiliate assets to the subsequent ECs (post

Mar 2021), the current affiliate is unable to properly conduct business and should be secured by the LPF to

ensure proper stewardship of all LPF branding, materials, funds, etc.

This will allow affiliates to get paid out through the program for members of the affiliate who hold

membership with Moose International.

Moose International is a service organization founded in 1888, and boasts a membership of over a million,

with a presence in all 50 states, four Canadian providences, and Great Britain. Moose International

contribute \$75 - \$100 million in community service annually within their organization.

Moose International believes that "You are the one determining what you want to get out of the

organization, and what you want to give back"; this is to say that each lodge is given the flexibility to

determine what service activities they want to participate in as a lodge. As a result, Affiliates shall be

expected to show that affiliate members who are involved with Moose International are active in service

activates within their lodge in order to receive payment.

F. Motion No. 732

Title: Motion for Branded Table Cloths

Mover: J Mark Barfield

Motion: On behalf of the Communications Committee, I move to expend an amount not to exceed \$700

from the State Fund to purchase three LPF-branded Table Cloths.

Discussion:

This would provide dais table coverings bearing the current LPF Logo, approved by the Board last year. The table cloths we used at the 2021 Convention feature the old logo and are therefore, out of date. This Motion would be a move modernize our appearance and provide a consistent look with our banner and our photo

wall.

The Committee recommended cloths are from 4imprint and are adjustable for 6- or 8-foot tables, just like the current cloths which were also obtained rom 4imprint. This allows for adaptation to available tables, such as two 6-foot tables on stage and a single 8-foot table for sign in. The design is dark grey with the complete Libertarian Party of Florida banner logo in white and goldenrod. We could go with white cloths which would allow for the four colors of the logo. More care would be needed as white cloths would likely

get visibly dirty with repeated handlings.

The additional \$48.66 is unlikely to be used, but would allow for possible unforeseen changes in shipping

Title: Motion to Direct the LPF Rules Committee to Review and Report on Affiliate Governing Documents.

Mover: John Paff

Motion: Whereas, during the Executive Committee's November 21, 2021 approval of Manatee County's affiliation, a question arose regarding whether Manatee's governing documents conflicted with those of the LPF, and

Whereas, in his August 16, 2021 e-mail (link below) with the subject line "Meeting Feedback," the Vice Chair of the LPF Rules Committee opined that "[t]here are serious issues with the governing documents of Lee and Charlotte counties" in that he had "found multiple sections which, at best, are in conflict with LPF rules, at worst, may run afoul of the law." The e-mail went on to state that the Vice-Chair "ran a few of these issues [by the Rules Committee Chair] who shared some of his concerns," and

Whereas, a table containing a partial list of known County Affiliate governing documents (see link below) shows that many have seasoning requirements, revoked membership voting restrictions and other provisions that could arguably run afoul of the LPF governing documents or state law, and

Whereas, the issue of the validity of county affiliates' governing documents is an ongoing concern that needs to be put to rest, it is therefore:

Resolved, that the LPF Rules Committee is directed to review the governing documents of all the County Affiliates and report back to the Executive Committee, at or before the Executive Committee's January 2022 regular meeting. The Rules Committee's report shall, at a minimum, recite:

A. For each Affiliate, which provisions of its governing documents, if any, conflict with state law.

B. For each Affiliate, which provisions of its governing documents, if any, conflict with LPF governing documents or rules.

C. For each conflict reported under Paragraph B above, a recommendation as to whether 1) the Affiliate's governing document needs to be amended or 2) whether the LPF governing documents should be amended to accommodate the provision in the Affiliate's governing documents.

Disposition: Mr. Roos seconded. Mr. Appler moved to postpone the motion indefinitely; Ms. Gilmore seconded. Motion to postpone indefinitely passed.
