**1. Eligibility:** Sweepstakes (the “Sweepstakes”) is open only to those who sign up at the sweepstakes page located at **[URL to sweepstakes]** and who are **[age]** as of the date of entry. The sweepstakes is only open to legal residents of **[eligible countries]** and is void where prohibited by law. Employees of **[company name]** (the “Sponsor”) their respective affiliates, subsidiaries, advertising and promotion agencies, suppliers and their immediate family members and/or those living in the same household of each are not eligible to participate in the Sweepstakes. **2. Agreement to Rules:** By participating, you agree to be fully unconditionally bound by these Rules, and you represent and warrant that you meet the eligibility requirements set forth herein. **3. Sweepstakes Period:** Entries will be accepted online starting on or about **[start date]** and ending **[end date]**. All online entries must be received by **[end date]** 11:59PM EST.

**4. How to Enter:** The Sweepstakes must be entered by submitting an entry using the online form provided on this Sweepstakes site, located at **[URL to sweepstakes]**. The entry must fulfill all sweepstakes requirements, as specified, to be eligible to win a prize. Entries that are not complete or do not adhere to the rules or specifications may be disqualified at the sole discretion of **[company name]**. You may enter only once and you must fill in the information requested. You may not enter more times than indicated by using multiple email addresses, identities or devices in an attempt to circumvent the rules. **6. Odds:** The odds of winning depend on the number of eligible entries received.

**7. Winner selection and notification:** Winners of the Sweepstakes will be selected in a random drawing under the supervision of the Sponsor. Winners will be notified via email to the email address they entered the Sweepstakes with within five (5) days following the winner selection. **[company name]** shall have no liability for a winner's failure to receive notices due to winners' spam, junk e-mail or other security settings or for winners' provision of incorrect or otherwise non-functioning contact information. If the selected winner cannot be contacted, is ineligible, fails to claim the prize within 72 hours from the time award notification was sent, or fails to timely return a completed and executed declaration and releases as required, prize may be forfeited and an alternate winner selected.
