Pretty much the entire Congress (House and Senate) is bought by their donors. These donors provide funds in the form of campaign donations that purchase the ads, staff, travel, etc. – things that become the reason a candidate is seen by the public, dictate how they are seen, and is ultimately what voters will base their decision/vote on. There's also illegal bribery, lobbying and other legal forms of bribery, blackmail, and the threat of death or impeachment (think JFK and Clinton). There is also a revolving door, so that spoken and unspoken promises of employment are made. Basically, if someone in government does something favorable for a certain company; they get to go work for that company after they leave office. And individuals from companies who pay-to-play or who have influence, go work in government, where they usually make decisions to benefit the company they just came from (think Goldman Sachs). Congress is also controlled by others with great influence, such as those who are members of certain families or groups. In short, the US government is totally corrupt and totally controlled. And I'm only going to cover some of this corruption and control as it pertains to money, and I bet you'll still be left in a state of shock ... and utter disgust.

“The House of Representatives is made up of 435 elected members, divided among the 50 states in proportion to their total population. In addition, there are 6 non-voting members, representing the District of Columbia, the Commonwealth of Puerto Rico, and four other territories of the United States: American Samoa, Guam, the U.S. Virgin Islands, and the Commonwealth of Northern Mariana Islands. The presiding officer of the chamber is the Speaker of the House, elected by the Representatives. ... The Senate is composed of 100 Senators, 2 for each state. Until the ratification of the 17th Amendment in 1913, Senators were chosen by state legislatures, not by popular vote. Since then, they have been elected to six-year terms by the people of each state. Senators’ terms are staggered so that about one-third of the Senate is up for reelection every two years. ... The first step in the legislative process is the introduction of a bill to Congress. Anyone can write it, but only members of Congress can introduce legislation. ... After being introduced, a bill is referred to the appropriate committee for review. There are 17 Senate committees, with 70 subcommittees, and 23 House committees, with 104 subcommittees. The committees are not set in stone, but change in number and form with each new Congress as required for the efficient consideration of legislation. ... A bill is first considered in a subcommittee, where it may be accepted, amended, or rejected entirely. If the members of the subcommittee agree to move a bill forward, it is reported to the full committee, where the process is repeated again. Throughout this stage of the process, the committees and subcommittees call hearings to investigate the merits and flaws of the bill. They invite experts, advocates, and opponents to appear before the committee and provide testimony, and can compel people to appear using subpoena power if necessary. If the full committee votes to approve the bill, it is reported to the floor of the House or Senate, and the majority party leadership decides when to place the bill on the

calendar for consideration. If a bill is particularly pressing, it may be considered right away. Others may wait for months or never be scheduled at all.”

“Combative self-made billionaire Sheldon Adelson, who assembled the world's largest casino empire and used his fortune to nurture conservative politicians and policies in the United States and Israel, has died at age 87. The American casino mogul, raised in a poor Jewish immigrant family in Boston as the son of a cab driver, established lavish hotels and casinos in Las Vegas, Macau and Singapore, and headed the world's largest casino company, Las Vegas Sands Corp. ... He was a vigorous supporter of U.S. President Donald Trump, former U.S. President George W. Bush and Israeli Prime Minister Benjamin Netanyahu as well as a prolific donor to U.S. Republican politicians and foe of Democrats, including former U.S. President Barack Obama. ... Known for his extensive philanthropy and business ventures in Israel and donations to Jewish causes, Adelson counted Netanyahu as a close friend. ‘Sheldon's tremendous actions to strengthen Israel's standing in the United States and the connection between Israel and the (Jewish) Diaspora will be remembered for generations,’ Netanyahu said in a statement. Adelson and his Israeli-born physician wife Miriam gave more than \$218 million to Republican and conservative causes in the 2020 U.S. election cycle, according to the Center for Responsive Politics, which tracks political spending, more than anyone else. They

were prolific backers of Trump's 2016 presidential bid and remained supportive throughout his turbulent presidency. The casino magnate was in regular contact with Trump after he took office and saw some of his cherished goals relating to Israel come to fruition including the moving of the U.S. embassy to Jerusalem in a break with decades of American policy. Adelson attended the embassy dedication ceremony in May 2018. 'I'm against very wealthy people attempting to or influencing elections. But as long as it's doable, I'm going to do it,' Adelson told Forbes magazine in 2012.”

“George Soros may draw some of the most vociferous criticism, but he’s hardly the biggest political donor in this cash-heavy election cycle — Democrat or Republican. In fact, Soros is 24th on the largest givers in this cycle, and Jewish donors on both the right and left populate the list above him. That’s according to Open Secrets, which provides the top 100 individuals or married couples donating to the 2020 campaign. Among the top 25 on the list, 15 are Jewish or of Jewish origin. They include Tom Steyer, No. 1 on the list, and Donald Sussman, who have joined Soros in the litany of Democratic donors criticized by Republicans. Miriam and Sheldon Adelson are No. 5 — their money goes exclusively to Republican candidates. Plus there’s a host of Jewish donors who have drawn little public attention despite giving in the multimillions.”

“The distinction between legitimate critique of Soros’ activism and anti-Semitic invective is not always clear. Republican officials have sparked backlash from liberal groups by calling out Soros and other Jewish donors for financing Democratic campaigns. The officials, House Republican Leader Kevin McCarthy and Sen. Susan Collins of Maine, do not have histories of anti-Semitism and did not identify the donors as Jews. The donors in question are in fact among the leading funders of Democratic campaigns. But critics said the statements nonetheless invoked the anti-Semitic trope of rich Jews using their money to control politicians. In October 2018, McCarthy tweeted, ‘We cannot allow Soros, Steyer and Bloomberg to BUY this election!’ Michael Bloomberg is also Jewish, and Tom Steyer is of Jewish descent. The tweet also displayed a grainy, black-and-white photo of Soros. Steyer and Bloomberg were the top two Democratic donors in the 2018 cycle, while Soros was the fifth largest, according to the [OpenSecrets campaign finance database](#). McCarthy [deleted the tweet](#) days later because it had come days before a pipe bomb was mailed to the Soros home. The California lawmaker defended the tweet by [saying](#) it ‘had nothing to do about faith’ and ‘All I was pointing out was money that Republicans and Democrats were spending to defeat one another.’ Last month, Collins ran into a similar issue when she accused the Senate’s Democratic leader, Chuck Schumer of New York, of being ‘motivated by power,’ and called out two donors to her opponent’s campaign, Donald Sussman and George Soros. Sussman, Soros and Schumer are all Jewish.”

“While both parties have their billionaires, Republicans have many more. Of the 25 top donors this cycle, 18 are Republican, according to Open Secrets, and they have outspent Democrats by \$200 million. Billionaires make up 20 percent of total Republican donations compared with 14.5 percent of Democratic donations. Even that may understate the disparity. The largest donor of 2022, by far, was a Democrat, George Soros, whose contributions of at least \$126 million were nearly double the roughly \$67 million that the next two largest donors, the Republicans Richard Uihlein and Kenneth C. Griffin, ponied up each.”

“During the 2022 midterms, one of the super PACs affiliated with the American Israel Public Affairs Committee lobbying group—called the United Democracy Project—spent more than any other outside group during the Democratic primaries. Yes, it was spending on Democrats. But it boosted only conservative Democrats who were in races against progressive legislators, in part because progressives are, as a whole, willing to criticize Israel, and sometimes even question unconditional military aid to Benjamin Netanyahu’s government. AIPAC’s most successful sally in 2022 was kicking Andy Levin—not only one of the most prominent Jewish members of the House, but also a former synagogue president—out of his House seat in Michigan, in favor of a more conservative, non-Jewish representative in Haley Stevens. (Levin had dared to indicate support for a two-state solution, introducing [a bill](#) that would have prevented U.S. aid from being used to fund Israeli settlements in the West Bank and that recognized East Jerusalem as ‘occupied territory,’ among other provisions.) And all of that was before Israel’s devastating war in Gaza began. Now, AIPAC has made it a clear goal to defeat every progressive Democrat it can in 2024. At the end of January, Federal Election Commission filings revealed that the United Democracy Project super PAC already had [\\$40 million on hand](#) by the end of 2023, nearly double the \$26 million it spent on the 2022 midterms. Those numbers will likely skyrocket further.”

The bundler, granted anonymity to discuss internal strategy, said AIPAC is expanding on its 2022 playbook, “but it also sounds like they’re going to go more actively after the Squad, people like [Reps.] Cori Bush [D-Mo.] and Jamaal Bowman [D-N.Y.]”

Several donors or donor advisers close to AIPAC cited Bush and Bowman as top targets, primarily because they’ve drawn formidable, AIPAC-endorsed primary opponents and have struggled individually in fundraising. Bush, who has become one of the sharpest critics of the Israeli government, is facing Wesley Bell, a St. Louis County prosecutor who started this year with more than \$400,000 in the bank. Bush, in contrast, had \$215,000 in cash on hand.

In New York, AIPAC recruited Westchester County Executive George Latimer to run against Bowman, and the group has raised at least \$350,000 directly for his campaign.

“AIPAC and their Republican mega donors are targeting Black and brown Democratic incumbents with the same right-wing playbook across the country,” Bush said in a statement.

... The expansiveness of AIPAC’s battlefield primarily comes from its roster of mega-donors. They’re backed by Democrats, like media executive Haim Saban, and Republicans, like former Home Depot CEO Bernie Marcus and billionaire financier Paul Singer. But those GOP donors give progressives, they believe, an opening to attack AIPAC, aiming to turn their endorsement toxic in primaries. They also often

point to AIPAC's support of congressional Republicans who voted against certifying the 2020 election.

“A handful of Republican billionaire mega-donors are using AIPAC to spend in Democratic primaries against Black and brown progressives, funding primary campaigns against the most popular and progressive members, so this should be a scandal,” said Usamah Andrabi, communications director for Justice Democrats, a progressive group that's positioned against AIPAC. “The whole of the Democratic Party should be united in opposition to this.”

Min, the California state senator who has been pummeled by AIPAC-funded attack ads in the lead-up to his March 5 primary, has also tried to turn the group's conservative financiers into a political foil. His campaign blasted Weiss, his Democratic opponent, as having a “cozy relationship with dark Republican money.”

In recent weeks, AIPAC's super PAC has spent at least \$4.6 million on anti-Min television ads and mailers. The ads make no mention of his position on Israel — the same strategy they deployed in 2022 primaries. Instead, they largely focus on Min's arrest last May for drunk driving — a central plank in Weiss' argument that Min is too risky a choice for Democrats fighting to keep the toss-up Orange County district that Rep. Katie Porter held by less than four points last cycle.

AIPAC donors have showered Weiss with cash, donating nearly \$400,000 via the group in February, making her one of the top beneficiaries of AIPAC bundling so far this cycle.

The reasons for AIPAC's anti-Min barrage are somewhat inscrutable. While the Israel-Hamas war has exposed deep rifts in the Democratic party as a whole, neither Min nor Weiss had been especially vocal about

their positions on the war. In particular, Min never publicly called for a cease-fire — a litmus test for many on the left — and he was endorsed by the majority of California’s Legislative Jewish Caucus.

Min’s campaign attributed the dust-up with AIPAC to criticism he made of Israeli Prime Minister Benjamin Netanyahu in private conversations with members, as well as him being endorsed by J Street in the past.

“We support candidates from both parties solely based on one criteria – their commitment to strengthening the US-Israel relationship,” AIPAC spokesperson Marshall Wittmann said in an emailed statement. “We support scores of progressive candidates including the Democratic leadership and nearly half of the membership of the congressional Progressive Caucus, Black Caucus and Hispanic Caucus. In fact, we are the largest PAC contributor to Democratic candidates.”

The 2016 Democratic National Committee Email Leak

Read this excerpt from *2016 Democratic National Committee email leak*

The 2016 Democratic National Committee email leak is a collection of Democratic National Committee (DNC) emails stolen by one or more

hackers operating under the pseudonym "Guccifer 2.0" who are alleged to be Russian intelligence agency hackers, according to indictments carried out by the Mueller investigation.^[1] These emails were subsequently leaked by DCLeaks in June and July 2016^[2] and by WikiLeaks on July 22, 2016, just before the 2016 Democratic National Convention. This collection included 19,252 emails and 8,034 attachments from the DNC, the governing body of the United States Democratic Party.^[3] The leak includes emails from seven key DNC staff members dating from January 2015 to May 2016.^[4] On November 6, 2016, WikiLeaks released a second batch of DNC emails, adding 8,263 emails to its collection.^[5] The emails and documents showed that the Democratic Party's national committee favored Clinton over her rival Bernie Sanders in the primaries.^[6] These releases caused significant harm to the Clinton campaign, and have been cited as a potential contributing factor to her loss in the general election against Donald Trump.^[7]

The leaks resulted in allegations of bias against Bernie Sanders's presidential campaign, in apparent contradiction with the DNC leadership's publicly stated neutrality,^[8] as several DNC operatives openly derided Sanders's campaign and discussed ways to advance Hillary Clinton's nomination. Later reveals included controversial DNC–Clinton agreements dated before the primary, regarding financial arrangements and control over policy and hiring decisions.^[9] The revelations prompted the resignation of DNC chair Debbie Wasserman Schultz before the 2016 Democratic National Convention.^[10] The DNC issued a formal apology to Bernie Sanders and his supporters "for the inexcusable remarks made over email" that did not reflect the DNC's "steadfast commitment to neutrality during the nominating process."^[11] After the convention, DNC CEO Amy Dacey, CFO Brad Marshall, and

Communications Director Luis Miranda also resigned in the wake of the controversy.^[12]

... According to the *New York Times*, the cache included "thousands of emails exchanged by Democratic officials and party fund-raisers, revealing in rarely seen detail the elaborate, ingratiating and often bluntly transactional exchanges necessary to harvest hundreds of millions of dollars from the party's wealthy donor class. The emails capture a world where seating charts are arranged with dollar totals in mind, where a White House celebration of gay pride is a thinly disguised occasion for rewarding wealthy donors and where physical proximity to the president is the most precious of currencies."^[42] As is common in national politics, large party donors "were the subject of entire dossiers, as fund-raisers tried to gauge their interests, annoyances and passions."^[42]

In a series of email exchanges in April and May 2016, DNC fundraising staff discussed and compiled a list of people (mainly donors) who might be appointed to federal boards and commissions.^[43] OpenSecrets senior fellow Bob Biersack noted that this is a longstanding practice in the United States: "Big donors have always risen to the top of lists for appointment to plum ambassadorships and other boards and commissions around the federal landscape."^[43] The White House denied that financial support for the party was connected to board appointments, saying: "Being a donor does not get you a role in this administration, nor does it preclude you from getting one. We've said this for many years now and there's nothing in the emails that have been released that contradicts that."^[43]

“On September 13, WikiLeaks lived up to its promise of releasing more Democratic National Committee (DNC) documents. This time they were from hacker Guccifer 2.0, serving as a teaser for larger and likely more embarrassing leaks from the DNC and Hillary Clinton campaign. ... The leaks include more evidence of overt corruption within the DNC. One email dated May 18, 2016, from Jacquelyn Lopez, an attorney with the law firm Perkins Coie, asked DNC staff if they could set up a brief call ‘to go over our process for handling donations from donors who have given us pay to play letters.’ Included in the leak was a list of high-profile donors from 2008 and the ambassadorship they received in exchange for their large donation to the DNC and Barack Obama’s Organizing For Action (OFA). Essentially, Obama was auctioning off foreign ambassador positions and other office positions while Hillary Clinton served as secretary of state. The largest donor listed at contributions totaling over \$3.5 million, Matthew Barzun, served as U.S. Ambassador to Sweden from 2009 to 2011, served as President Obama’s National Finance Chair during his 2012 reelection campaign, and now serves as U.S. Ambassador to the United Kingdom. The second largest donor, Julius Genachowski, donated just under \$3.5 million to the DNC and OFA, and in exchange was appointed chairman of the FCC by

Obama in 2009. The third largest donor on the list, Frank Sanchez, donated just over \$3.4 million and [in] exchange was appointed to Undersecretary of Commerce for International Trade by Obama in 2010. A 2013 article published by the Guardian corroborates the pay-to-play scheme this list suggests. ‘Barack Obama has rewarded some of his most active campaign donors with plum jobs in foreign embassies, with the average amount raised by recent or imminent appointees soaring to \$1.8m per post, according to a Guardian analysis,’ wrote Dan Roberts. ‘The practice is hardly a new feature of U.S. politics, but career diplomats in Washington are increasingly alarmed at how it has grown. One former ambassador described it as the selling of public office.’”

But most on her mind, it seemed, was getting access to an exclusive November gathering at the White House. ‘Not assuming I am invited...just mentioning/asking, if in case, I am invited :),’ wrote Ms. Duggal, who was appointed by Mr. Obama to oversee the United States Holocaust Memorial Museum and is married to a San Francisco financial executive. ‘Might you have an intel?’ Ms. Duggal’s note was

among 19,000 internal Democratic Party emails released on Friday by WikiLeaks, setting off a frenzy on the eve of the party's quadrennial nominating convention and forcing the resignation of the party chairwoman, Debbie Wasserman Schultz. Some of the emails revealed internal discussion by committee officials — obligated under party rules to remain neutral in the presidential primary — about how to discredit Senator Bernie Sanders of Vermont, enraging some of his supporters. ... The leaked emails span the period from January 2015 to late May of this year, during which Mr. Obama was the party's chief fund-raising draw but the Democratic National Committee was beginning to raise money jointly with the party's presumed future nominee, Mrs. Clinton. Many revolve around donors' efforts to qualify for top packages at the convention that begins Monday in Philadelphia. Donors who raise \$1.25 million for the party — or who give \$467,000 — are entitled to priority booking in a top hotel, nightly access to V.I.P. lounges and an 'exclusive roundtable and campaign briefing with high-level Democratic officials,' according to a promotional brochure obtained by The Times. For some donors, Mr. Obama's personal presence was most important. In an exchange in May, committee finance staff members debated how to preserve a \$350,000 fund-raiser to be hosted by Carol Goldberg, an artist, and her husband, Hank Goldberg, a real estate executive. The Goldbergs had been eager to host Mr. Obama at their home, in Chevy Chase, Md. But after White House officials concluded that the extra drive was not a good use of Mr. Obama's time, aides discussed proposing to the family that they could instead host with other donors an event at the Jefferson Hotel, a luxury establishment near the White House. Another staff member, given the task of letting the Goldbergs down, knew they would be disappointed. 'I think the excitement of hosting at home was a big factor,' he wrote. The Goldbergs pulled out of the fund-raiser. In some cases, the party offered donors the chance to

join ‘roundtables’ — meetings for major givers disguised as high-minded discussions of national economic and social policy, where wealthy givers are treated as savants and sages. ‘Wonderful event yesterday,’ Robert Pietrzak, a New York lawyer and top Obama fund-raiser, wrote to a committee fund-raiser after he participated in an event with Mr. Obama in May. ‘A lot of foreign policy, starting with my question on China. The President was in great form.’”
