**Scholarship Criteria.** The criteria for the scholarship is as follows;

- 1. Completion of at least one full year of law school;
- 2. A current law school transcript (does not need to be an official transcript) indicating a minimum GPA of at least 2.7;
- 3. A current resumé;
- 4. One letter of recommendation from an Elon Law faculty member; and
- 5. A letter from the student (no more than two double spaced pages) detailing:
  - their motivation for attending law school
  - connection to Guilford County, NC and/or intention to practice in the county following graduation
  - any scholarships and merit-based financial support currently receiving
  - any community and/or pro bono service as a law student
