

(CONTENT WARNING: IMPLIED BODY HORROR)

KRIS SOLIS HC- DEB

(Check was conducted by Jemima Derry, police officer resident of Deborah.)

(Camera feed begins. Derry is facing the Solis household. The door is open.)

DERRY: Jemima Derry, resident officer for the protection and safety of Deborah's citizens. Warrant obtained for investigation into House 31, 2804 Lantern Way, inhabited by Kris Solis and his two daughters.

DERRY: I will not comment opinions for the remainder of this video, so as to properly document the surroundings.

(Derry proceeds inside the house. The inside looks torn up, as though a struggle had taken place. A few flashes are visible, Derry is assumed to have photographically documented the scene.)

(Kitchen is entered. Dishes are piled in the sink. Some have broken on the floor. The cupboards are empty. A few drawings are pinned to the fridge. Rustling of paper as Derry is assumed to collect these.)

(Master bedroom is empty. A large bug crawls along the wall in view of the camera. Fabrics in the room are torn down and slashed. Derry takes photo.)

(Transition period. Items heard moving. Camera feed blurry.)

(One children's bedroom with two bunk beds. One of the bunk beds is collapsed. Drawings further decorate the room. Blankets are strewn across this room as well. Dust fills the room. Derry takes photo.)

DERRY: Proper search of the household concluded. No individuals present within the house. Searching the outside.

(Derry proceeds to the back of the house, at which point a stifled gasp is heard and the camera shakes and unfocuses. When it refocuses, it is pointing towards the back porch covering.)

(A large woodchipper is present at the back of the yard. Below this woodchipper, a metal bucket sits. It is almost completely full of an indistinguishable chopped pinkish substance. Broken ropes are tied around the porch overhang posts, their torn ends leading into the chipper's teeth. The woodchipper, the bucket and the surrounding ground are all stained deep red. A note, also stained, sits near the bucket.)

(Five minutes pass. The camera shakily approaches and looks into the bucket. Extensive rustling in the background. Derry's hand, now gloved, slowly reaches into the bucket and feels around.)

(Thirty seconds pass. Derry pulls out a scrap of fabric.)

(Forty-three more seconds pass. A choking sound is audible. Derry pulls out a piece of hair.)

(Derry stands up jerkily and takes the handle of the bucket. Camera feed cuts out. Two minutes pass.)

(Camera feed cuts back in. Derry is standing back outside the house. Her voice sounds significantly more unsure.)

DERRY: House 31... deemed currently uninhabited. Evidence found will be analyzed. No current residents.

(Pause. Derry seems to be hesitating.)

DERRY: ...Order given to turn off heating moderation in the household.

(Camera feed ends.)
