CODE	DESCRIPTION	COUNTS AGAINST EXEMPTION? ✓ = NO; ✗ = YES
BB	student in building but not in class (e.g., Counseling Center, testing, tutorials, etc.)	✓
CD	college day visit	✓
DF	immediate family (parent, sibling, grandparent) funeral	✓
DL	appointment at DPS for drivers license; first absence does not count against incentive, following absences do count against incentive	✓ (first absence) ✗ (following absences)
DR	note provided for partial absence due to medical appointment	✓
F2	parent notified office the student was absent due to family reasons	✗
FT	field trip	✓
GF	funeral attendance (not immediate family)	✗
IL	parent notified office student missed due to illness	✗
ME	student left for doctor's appointment; no note provided	✗
P2	school-sponsored event	✓
PR	parent-requested absence	✗
SP	school-sponsored event	✓
TR	truant; accounted for by an administrator	✗
