Lake Anna Swim Company (LASC) Liability Waiver & Policies

PLEASE READ THIS DOCUMENT CAREFULLY. BY SIGNING, YOU WAIVE CERTAIN LEGAL RIGHTS.

Assumption of Risk & Liability Release

I, the undersigned participant or legal guardian, understand that swimming involves inherent risks, including but not limited to drowning, injury from slips and falls, and physical exertion. By voluntarily participating in swim lessons or related activities with Lake Anna Swim Company (LASC) at any location, I acknowledge and assume all associated risks.

I agree, on behalf of myself, my child(ren), heirs, assigns, and personal representatives, to release, waive, and discharge LASC, including its owner, employees, contractors, agents, sponsors, volunteers, instructors, host site owners, and successors, from any liability, claims, demands, actions, or causes of action arising out of injury, illness, property damage, or death resulting from participation in swim lessons, to the fullest extent allowed by law.

No Lifeguard on Duty: I understand that no lifeguard is on duty at lesson locations and that I, as the parent or caregiver, am solely responsible for supervising all minors outside of their designated lesson time. LASC instructors are responsible only for the enrolled swimmer during their scheduled lesson. Any other individuals in or around the pool are the sole responsibility of the parent or caregiver.

Compliance with Rules & Safety Regulations

All participants and spectators must follow LASC and host site rules, including:

- Parents/caregivers must remain poolside but outside the immediate teaching area unless participating in a Parent-Tot lesson.

- Siblings and friends may not be in the lesson area unless actively enrolled.
 - The pool must meet safety and HOA regulations (if applicable) for mobile lessons. LASC reserves the right to cancel or reschedule if the environment is deemed unsafe.

Media Release

I grant Lake Anna Swim Company full permission to take, use, and publish photos and videos of lessons, including underwater footage, for instructional and promotional purposes. This includes, but is not limited to, social media, websites, and marketing materials. If I do not consent, I must submit a written opt-out request via the provided Google form before lessons begin.

Medical Certification & Emergency Authorization

I certify that the participant is in good physical health and has no conditions preventing full participation. In case of a medical emergency, I authorize LASC to take appropriate actions, including arranging medical treatment or transport. I assume full responsibility for any medical costs incurred.

Registration & Payment Policies

- Registration is completed via Acuity, phone, or email and confirmed with the instructor.
- A **non-refundable \$185 deposit** (the hourly rate) secures a spot for Private Mobile Summer Lessons (not applicable to indoor lessons at Wilderness Presidential Resort or other partner pools). This deposit is applied toward the total lesson cost.
- The remaining balance is due by the first lesson date.

All Lessons & Programs Cancellation Policies:

- Cancellations or reschedules can be made **at least 24 hours before** the scheduled lesson time via the scheduling app.
- Cancellations made within **less than 24 hours** of the lesson time will result in the lesson fee being forfeited, unless rescheduling is approved by the instructor.
- **No-shows** (missed lessons without prior notification) will forfeit the lesson fee. A text message to the instructor as a courtesy is appreciated.
- Lessons may be rescheduled based on instructor availability.

Summer Lessons:

- Offered at multiple partner pool locations in the Louisa County/Lake Anna area.
- Mobile lessons at private residences start at \$185/hour.
- Available **June, July, and August**.

Wilderness Lessons (September - May):

- Lessons **before 10 AM** are exclusive to LASC participants.
- Lessons **after 10 AM** take place in designated areas while the pool is open to resort members and guests.
 - Instructor may need to reschedule lessons when the WPR pool is rented by members and guests or if an unexpected crowd causes an ineffective environment.

Weather & Instructor Cancellations

- LASC will notify clients of inclement weather cancellations and reschedule or refund as needed.
- Communication is sent via **TEXT** to the number(s) provided in this signed waiver.
- If an instructor must cancel for any reason, the lesson will be rescheduled.

Client Responsibilities

- **Pool Preparation (Mobile lessons):** Ensure the pool is clean, free of debris, and accessible.

- **Swimmer Readiness:** Participants should arrive on time, dressed in swimwear, pack a towel, swim diapers required for all participants not potty trained . Goggles are optional.
 - **Special Needs/Concerns:** Communicate any accommodations in advance.
