NOOS members

NOOS working groups

- WG on rivers is not a group and not working. (Johannes). There is an invitation to contact Jacob for interest and expectation for the Rivers WG. Breo mentions that there's a team at the MET office that is interested. There are also colleagues at Met Eireann that its interested.

Henning mentions that we could also reach out to IbiROOS or other EuroGOOS groups. Other regions could learn from things we do in the North Sea. Only be aware of the fact that you exceed the NOOS scope.

Susanne mentions that some colleagues of the BSH are interested of the Renewal Energy WG. They have been added to the WG, but up till now she wasn't aware of the topics, but after the presentation by [fill in name], it became more clear. She takes it home and will discuss it internally to find persons in the BSH. Second, sub WG on Waves by Susanne and Wiebeke. To find insight in wave data in Europe. It would be good to look back into that and start it up.

Henning: question about amount of WG. There are a lot of activities, but all valid. There is no need to evaluate whether the amount of WG should be altered.

Breogan mentions a different model in organizing the WGs. All WGs are free to organize their group on the way they want. It's good to have a person of contact to the chair.

NOOS ambassadors

All ambassadors are willing to continue.

Kai (BSH) suggests that the new ambassadors re-connect with the observing community. Therefore all ambassadors are requested to inform how we could re-connect with the observations. Johannes (Hereon) will contact other Hereon people to get insight in the updates of the HF radar etc.

Torleif Lothe (NORCE) suggests to set-up a LinkedIn community. Multiple attendees agree with this suggestion. It could also help with the easy communication task set up by the SG where Slack turned out not to be the best platform. It can be used to share insights, papers, and others. The Steering Committee will pick it up. This is added to the action list.

Steering committee
