After analyzing the Reid Plan and the Reid-Boehner compromise, as critiqued by the CBO, I released "The Synthesis" early, our weekly Tea Party circular to give everyone access to the information instead of media sound bytes and pleas from worried politicians. I have had more than 60 views on my blog since yesterday morning, and the circular reaches 20,000 from my email log and Facebook groups, not counting resharing or Twitter. This topic has generated such interest in what was said in this newsletter, that it has had more views than any topic I've posted in nearly two years.

I urge members of both bodies to not vote for either plan, as they do not

make enough cuts to address the "\$1.7 trillion debt supercycle/interest" in raising the debt ceiling. While these plans may stay our credit rating, it will be jeopardized again, and rather quickly as of next Spring. I do not see the debt ceiling as a singular issue, when it is a mute point when we have already hit our head, and the interest is already accruing.

However, I do feel to avoid default on 8-2-2011, we must:

- 1) Pass an emergency contingency measure to appropriate what is necessary to avoid default.
  - This will not only buy us time to meet and compromise more, but it will give us time to vote on all the plans to preserve the credit rating without sacrificing it to political stalemate tactics and delays.
- 2) We must then consider up or down votes on the 6 plans, to be fair to all sides.
  - The Biden Commission/Plan only cuts \$1.3 trillion not enough to even present a vote to the floor, but we can give it a floor vote like the rest.
  - The Reid Plan cuts \$2.2 trillion but spends \$2.7 trillion, [so it only cuts \$.5 trillion], it protects the credit rating but it certainly not enough to avoid the interest of the "\$1.7 trillion debt supercycle/interest" in raising the debt ceiling. The caps don't go far enough either, the promise to cap rather than designate what will be capped, when we shouldn't have any new spending in a deficit.
  - The Boehner-Reid Compromise plan cuts \$2.7 trillion, spends \$2.5 trillion, which protects the credit rating but only cuts \$.2 trillion; which is not enough! The problem is getting an agreement to make the Balanced Budget Amendment a Constitutional Amendment. There are concerns about rule changes, who would be on the Deficit Reduction Committee, and the caps go too far to get the votes when they are too generalized.
  - THE GANG OF SIX PLAN CUTS \$4.3 TRILLION OVER 10YRS., INCREASES REVENUE OF \$1 TRILLION IN EXCHANGE FOR CUTS: MEDICARE, MEDICAID, AND SOCIAL SECURITY, ADHERING TO A \$3 FOR \$1 OF TAXPAYER REVENUE REDUCTION IN SPENDING TO OFFSET INTEREST. THE COMPROMISE WAS TAX REFORM.
  - THE RYAN PLAN CUTS \$6.2 TRILLION, INCREASES REVENUE \$1.5 TRILLION, ADDRESSES THE INTEREST AND ROOT CAUSE OF CREDIT DEFAULT MECHANISMS, PASSED THE HOUSE FOR 2012 BUDGET: The Path to Prosperity will help create nearly one million new private-sector jobs next year, bring the unemployment rate down to 4% by 2015, and result in 2.5 million additional private-sector jobs in the

last year of the decade. It spurs economic growth, with \$1.5 trillion in additional real GDP over the decade. According to Heritage's analysis, it would result in \$1.1 trillion in higher wages and an average of \$1,000 in additional family income each year.

• THE COBURN PLAN - CUTS \$9 TRILLION, TAKES US BACK TO PRE-OBAMA LEVELS OF DEBT AND INTEREST, BUT CUTS TOO MUCH TOO SOON, IT REDUCES GOVERNMENT 20% WHEN WE NEED 10% REDUCTION NOW, AND 5X THE JOB CREATION!!

If a vote occurs today in the House and Senate, I urge members to go ahead and take a stand to support the Boehner-Reid Compromise, and for members to vote against the Reid Plan. This would clear 2 votes out of the way for the 6 plans, to shorten the amount of time that has been wasted and pave the way to greater compromise and consideration of plans we actually want and need.

I support and endorse the Gang of Six Bipartisan Plan. It compromises with both parties, has enough cuts, addresses revenue, deals with inflation, and it doesn't cut too much too soon, and it is the only plan Obama said that he would not veto because it contains elements of tax reform.

Until he is impeached, veto is still a threat undermining Cut, Cap, and Balance, the Balanced Budget Amendment, or any other initiatives by GOP and Tea Party to bring deeper cuts to address the interest accumulating on the deficit.



MY PREDICTION WAS THAT IF WE DID NOT REPEAL H.R. 4872, THAT WITH THE INTEREST ON THE DEFICIT, UNEMPLOYMENT TRENDS AND OTHER ECONOMIC PROBLEMS WE WOULD BE COMPLETELY DESTITUTE WITHIN 30-50 YEARS, AND IF WE DID NOT ADDRESS THE INTEREST OF THE DEBT SUPERCYCLE/GOVERNMENT DEFAULT, THIS COULD HASTEN IT IN AS LITTLE AS 7 YEARS !!!



WHILE WE CONTINUED TO FINANCE THE GOVERNMENT UNTIL NEXT SPRING, WHAT MOST DO NOT REALIZE IS THAT SINCE THE VALUE OF THE DOLLAR IS ONLY WORTH HALF, THEN WE ARE BORROWING \$500 BILLION, IT'S LIKE WE MUST PAY BACK THAT \$500 BILLION BACK TWICE, AND THEN THERE IS THE INTEREST ON THAT AMOUNT:

Why is this a jobless recovery with 25 million people out of work? It's because of uncertainty about the Reconciliation Act of 2010:

PROPOSITION FOR A REPEAL BILL TO REPLACE H.R. 4872:

While Obama is definitely right about the urgency to tackle health reform, (as costs are exorbitantly high and we have no program for the uninsured), if we do not create a program to cover the uninsured or reform health care, we will add another \$3 trillion to the deficit! The cost of not reforming health care over the next decade will double, adding half of the current deficit, to the \$13 trillion dollar deficit, and if we do nothing about it now, half of the deficit by 2020 is projected to be nothing but health care debt: created by 20 years of unwise Congressional spending and legislation, a whopping \$20 trillion dollars in the red!

It is not enough to say to the Federal Reserve to print more money for a bailout when the cost of food and gas are inflated, and since we're a global economy that enjoys fiat, meaning that the American dollar is the only currency that is backed by the government who can write own notes, and while this is a supreme position of financial power and financial and influence, this also makes us vulnerable to attack from other countries who covet our position and status. Essentially, if you control the value of the American dollar, by buying up gold, property, or investments backed by gold, you have the power to control the global economy, and depending on how much you have, it's like using reigns on a horse. The more wealth you have, the more you control sectors of society, like strings of puppets. I have seen Obama depicted as Puppet Master, but the true Master of Money is the person who is the wealthiest in gold, American property, and investments. While it is true that Obama has written a lot of blank checks, in 2004 it was estimated that the government has 261,007,000,000 ounces of gold/\$2,800 per ounce, so the gold value was \$730,819,600,000 with \$733,170,953,704 American dollars in circulation, which leaves \$730,086,429,046,296, or about \$730 trillion dollars in reserve.

If we were to sell off our gold to pay down the deficit, the United States is only then worth around \$700 trillion dollars. With our current financial problems and people being unemployed, the government is not collecting any real tax revenue from 25 million people over the past 2-3yrs. Qualified unemployment recipients who receive \$800 per month cost the government \$20,000,000,000/\$20 billion per month, and in one year \$240,000,000,000,000/\$240 billion, so for 3yrs. of unemployment that comes to an ungodly \$720,000,000,000/\$720 billion dollars, which by the end of this year will add \$1 trillion to the deficit! The government can't tax it's own money, or make enough back off of taxes from unemployment checks, as it was a government pay-out to begin with! The government gives out close to \$1 trillion and gets back only 1/10. The government is essentially loaning out money that was paid in by taxpayers, getting \$100,000,000/\$100 billion in revenue back for \$1 trillion paid out.

Continuing this disastrous trend with unemployment will add to the deficit at nearly the same rate as the health care debt, which would put the projected deficit to then \$25 trillion. Within the next 30-50 years, just with unemployment pay-outs and health care costs, the deficit will consume the entire value of gold that backs the U.S. dollar, and

we'll be penniless and gold-less, and we'll have no capital to loan or be able to loan to other countries! Whoever buys our gold will essentially be buying our debt! Even if we used the tax revenue generated off of unemployment checks, that \$100 billion, and bought gold with it, we would only add \$35 million and some back, which won't make but \$142 million over the next 12 years to offset trillions of dollars spent on unemployment and health care!

So folks, this is where the rubber meets the road: health care has been so high that people have been having to choose between their health or having a roof over their head, a car to drive, and food in their stomachs. This is the main reason the I.R.S. disagrees with Obama's wage control plan to levy the taxes to pay for health care, as even the I.R.S. knows that even if you took in more taxes to pay for a new health care program for the uninsured, Obama's legislation fails to deal with the costs of MEDICARE/MEDICAID rising, along with private sector premiums and out-of-pocket costs, so the money it costs to treat the uninsured being used as tax write-offs for hospitals would only address one kink in the hose, like putting a band-aid on a gaping wound that really needs stitches: there are 25 million unemployed who may or may not return to work, but there are really 3 groups of people who make up the uninsured bracket of society. Illegals make up 12 million, 10 million Americans don't have any insurance, and the other 25 million will get insurance at another job when they return to work or the ones who remain unemployed will be dropped from COBRA. Those who are insured now pay 8% higher premiums, as the hospitals charge insurance companies a percentage to offset the cost of operation for treating those not insured. Now with higher unemployment, insurance companies have jacked up their rates because of a lower pool for their policy.

The question is, why has universal care not worked for MA? MA is now carrying a deficit, against federal law, as universal care does not cover the cost of disability or address the costs of the aging population. MA's premiums only went down \$230 per year/per person, with much higher taxes, running a deficit, AND they STILL put disability appropriations on the chopping block, though that still didn't stop their deficit or really improve care, lower premium costs substantially, or even offset medical costs to balance their budget. Universal care just shuffles federal money out around the state, and it fails to deal with the cost issues of elderly care or special needs. Which is why C.B.O. numbers are b.s.!

Keeping all of these things in mind of what we can't keep doing and what has proven not to work, we can't just do it Obama's way to our country's own undoing! America will meet her demise at Obama's hand if we blindly follow him like sheep to the slaughter! We are to be wise as serpents, but harmless as doves, and while we've got to reform health care and do it N-O-W, even tort reform won't stop this health care abyss!

As a lobbyist in GA in over the past 8 months, I have conferred with Republicans to give approval to fund H.R. 3200, H.R. 3400, H.R. 1200 (striking the mandate clause), and H.R. 3962 with much revision. I addressed committee members to agree to compromise with

health care reform, and I garnered Republican concession to accept passage of 3 Democrats' bills to their 1 bill, with the condition that H.R. 3590 be tabled until it could be revised to address cost issues effectively. The bill was so bad, it was written by Rangel, and it was determined in committee to be a conflict of interest, and I actually believe that Obama was so jealous that I prompted legislators to support this compromise, that it trumped anything he'd ever done in 10yrs. voting present in the Senate, so he refused to have Pelosi support convening on H.R. 3590, which would've gotten the bill thrown out entirely over ethical challenge, and he took it upon himself to write another version of it, H.R. 4872/the Recon. The I.R.S. expansion will remain the same as in H.R. 4872, but the I.R.S. will have 3 new departments: wage division, premium division, and records division. The I.R.S. will do what it does best, collecting and recording accurate monetary and related information, and they will do do so by using the taxpayer ID# as a person's National Health Insurance number. This way, the I.R.S. will be able to easily assess and collect information having to review and substantiate gazillions of 1099 forms, and without having to harass or hunt people down, the I.R.S. would be the only entity to have access to private medical data through use of the Tax ID number, which will track and compile medical data as soon as we add it for hospitals to submit it for billing/tax purposes.

The I.R.S. will analyze all Tax ID claims, those who have opted-in to National Health Insurance, and track the costs to those under other insurance, and also track the costs of those who refuse health insurance and compile it for an annual report for Congress. 
While this bill is just a simple readjustment of how we do things, it may be amended or modified to fit legislative language and action as appropriate.

## Experts say Obama certificate not scan of original document

2 new reports cast further doubt on image White House released

Detailed technical analysis of the <u>PDFfile</u> the White House released April 27 indicates it is not a scan of the original document, as claimed by the White House, but instead is the final form of an electronic file used to forge the birth certificate on <u>Adobe</u> software, according to reports by experts.

Failure to demonstrate how a simple computer scan can produce the effects observed in the Obama birth certificate <u>PDF</u> lends support to arguments that the Obama birth certificate is a forgery, the experts contend.

#### **OBOTs** jump to defend Obama birth certificate

The radical Obama supporters known as OBOTs have repeatedly asserted that experts cited by WND have ignored evidence that the effects observed in the White House-released PDF can be explained by utilizing various tools, such as running Optical Character Recognition (OCR) software and by optimizing the PDF.

<u>Frank Arduini</u>, an OBOT who works at CareFusion and frequently posts argumentative pro-Obama comments on WND <u>forums</u>, made the charge in a recent WND-published article, as seen in Exhibit 1.



Arduini's <u>LinkedIn.com profile</u> lists him as an <u>IT Business Partner</u> at the health industries company <u>CareFusion</u>, headquartered in San Diego.

Kevin Davidson, who posts under the alias "Dr. Conspiracy," wrote the article referenced by Arduini, entitled <u>"The Doc got layers,"</u> posted July 9 on Davidson's <u>blog</u>, ObamaConspiracy.org.

<u>Davidson is retired from Netsmart Technologies</u>, an information technologies company whose business includes providing assistance in vital records management to state

organizations.

In an email to WND, Davidson professed that he never worked with the state of Hawaii and his former employer never had a vital records contract with the state.

He further stated that his Obama Conspiracy blog is "a personal hobby" that "was never connected to my employment."

Neither Arduini nor Davidson have demonstrated an ability to replicate what is observed in the Obama birth certificate PDF by scanning a <u>document</u> and utilizing optimization techniques.

#### Two White House PDF birth certificate files released

Various observers have pointed out that more than one PDF file was released by the White House, as noted in Exhibit 2.

The PDF I downloaded from the Whitehouse on the 27th is identical to the version available from there right now. A MD5 hash cannot be faked.

The archiveindex version is 3289 bytes longer, has a creation date on the 27th, has an additional modified date on the 28th, the format of the header, trailer and the dates has also changed.

Either the archiveindex.com version is not an original and has been modified and resaved, or the Whitehouse changed versions on the 28th and then changed back to the first version they made available sometime after the 28th.

The White House has never acknowledged or explained why two different PDF versions of the Obama birth certificate were filed on the White House website.

#### **Created in Adobe software?**

According to both versions of the Obama birth certificate PDF, the metadata embedded in the PDF file documents that the PDF was created in Macintosh Preview on an Apple computer using the MacOSX <u>operatingsystem</u>.

Exhibit 3 presents the metadata from the White House website, with the lines identifying the Apple computer and software highlighted in red.

Because the PDF metadata contained no references to Adobe software, many Obama supporters have argued that <u>AdobeIllustrator</u> or Photoshop were not used in the creation of the PDF file.

WND has obtained a technical analysis from a computer software expert who demonstrates conclusively that a document created in Adobe Illustrator or Photoshop can be read into Preview.

Further, Preview can be used to save the file as a PDF. In the process, all metadata from the Adobe software is eliminated in the new metadata file created for the resulting PDF. Moreover, when the Preview-created PDF file is read into Adobe Illustrator, the layers used to create the electronic file in Adobe Illustrator or Photoshop are visible, even though the PDF metafile does not document the Adobe software manipulations used to create the file.

Initially, when "Derek's file" was found in the metadata of the White House-released PDF, various posters on the Internet suspected the identity of the person within the White House who made the file.

At the time, computer software experts suspected Derek Noonburg held the patent on the version of PDF built into Mac Preview.

After an email exchange with WND, <u>Noonburg posted on his website</u> that he did not own that particular patent and that it was his suspicion "Derek's file" referred to the person who wrote the PDF generation software built into MacOSX.

WND has verified that "Derek's file" does appear in PDF files created with Mac Preview on the MacOSX operating system and is not related to any individual working within the White House.

The complete analysis showing that the White House-released PDF could have been created in Adobe Illustrator or Photoshop software can be read <a href="here">here</a>

"Whether the source file came from a scanner or was created in Adobe is unclear," the expert concluded. "Based on that fact, the 'digital chain of custody' of this document is unknown and the integrity of the data is unknowable from a technical perspective.

"Any number of processes and applications could have been used on this document between the time it was scanned and the time it was converted to its final PDF form." The computer software expert asked to remain anonymous, because much of his work comes from Adobe, and writing a report suggesting the Obama birth certificate is a fraud could be harmful to his career.

#### White House PDF not run with OCR


A second computer software expert has submitted to WND a report, seen here in its

entirety, that concludes the White House-released PDF could have been created in Adobe Illustrator or Photoshop, even if the final PDF was created by Mac Preview on an Apple computer using the MacOSX operating system.

This expert also insisted on remaining anonymous, fearing retailiation from Adobe or the Adobe community.

Typically, Obama supporters have observed that effects such as the multiple layers easily seen in the Obama PDF file through Adobe Illustrator were caused by optimizing the file with Optical Character Recognition software.

This second technical report concludes OCR software was not run on the White House-released PDF, because the file has no <u>information</u> in the "Fonts" field of the "Properties" tab when it is examined in Adobe Acrobat, as seen in Exhibit 4.




The point is that OCR software is designed to read words in an electronic file into a table so that the words can be manipulated by word-processing software. Failure to generate fonts in the White House-released PDF is evidence OCR software was not run on the file, the expert argues.

The analysis also rejects the contention that the combination of bitmap and continuous-tone letters in the Obama PDF was caused by optimization.

"The only way I have been able to replicate the piecemeal nature of the birth certificate (some continuous-tone content, some bipmap content) is by combining bitmap and continuous-tone images in Adobe Illustrator," the expert concludes.

In Exhibit 5, the small text, horizontal line and green pattern are all one continuous tone;

the 89567 numerals were saved from Photoshop as a bitmap TIFF image; the images were combined in Illustrator.



"I then saved the Illustrator file as an Adobe PDF, opened that PDF in Apple's Preview application and printed to PDF," the expert explains. "That approach comes closest to matching the attributes of the birth certificate PDF: bitmap plus continuous-tone content, some vector content, no embedded fonts and the Preview application stamp."

The expert concludes that the White House released PDE was not a simple seen, as

The expert concludes that the White House-released PDF was not a simple scan, as represented by the White House.


"I can only speculate on what's been done to produce the file as we see it," the expert writes. "But, in my opinion, the supplied PDF is not a pristine scan simply enveloped in a PDF wrapper. It's been touched by other processes."

### Optimized layers differ in appearance

Following expert advice, WND scanned an authentic birth certificate issued March 15, 2011, by the Hawaii Department of Health, a little more than a month before the Obama PDF birth certificate was issued.

The document was scanned into Adobe Acrobat and run through OCR software. The resulting document was opened in Adobe Illustrator.


Exhibit 6 confirms the March 15 document after being run through OCR only produces what appears to be two layers.




When the second layer is switched off, the entire document disappears, indicating that OCR software alone does not contain the type of multiple layers observable in the Obama birth certificate PDF when viewed in Adobe Illustrator.

Next, the authentic Hawaii DOH birth certificate issued March 15 was run through OCR and optimized.

Exhibit 7 confirms that this process creates multiple layers when the document is viewed in Adobe Illustrator.




As seen in Exhibit 8, the major effect of switching off layers in the PDF run with OCR and optimized is that white spaces appear at various places on the document – an effect not observed when the Obama birth certificate is viewed in Adobe Illustrator and layers are switched off.



Switching off layers in this document did not result in text that could be moved around, such as the registrar's date stamp and the registrar's text/signature stamp. As WND has reported, this is possible to do, however, with the Obama birth certificate PDF when viewed in Adobe Acrobat or in Adobe Illustrator.

Nor does switching off layers in this document permit a text level to be separated from the security background layer, as demonstrated in Exhibit 9.
