So let's go ahead and assess those right now.

In April 2021, Biden's six executive actions included:

The Justice Department, within 30 days, will issue a proposed rule to help stop the proliferation of "ghost guns."

The Justice Department, within 60 days, will issue a proposed rule to make clear when a device marketed as a stabilizing brace effectively turns a pistol into a short-barreled rifle subject to the requirements of the National Firearms Act.

The Justice Department, within 60 days, will publish model "red flag" legislation for states: Red flag laws allow family members or law enforcement to petition for a court order temporarily barring people in crisis from accessing firearms if they present a danger to themselves or others.

The Administration is investing in evidence-based community violence interventions.

The Justice Department will issue an annual report on firearms trafficking.

The President will nominate David Chipman to serve as Director of the Bureau of Alcohol, Tobacco, and Firearms.

In one of his last gun control executive orders, Biden targeted private gun sellers.

"The executive order directs the attorney general to increase background checks by cracking down on gun sellers who don't perform them when required, with the goal of "moving us as close as we can to universal background checks without new legislation," as Mr. Biden put it. The order also directs federal agencies to improve public awareness and promote the use of "red-flag" laws, and instructs the attorney general to release more information about federally licensed firearms dealers who violate the law," CBS News reported.

Shortly before leaving office, Joe Biden signed an executive order banning ghost guns.

Biden also targeted gun manufacturers and vowed to ban assault weapons and high-capacity magazines.

BONUS : 11. His effort to instruct Congress to impeach these Federal Judges

**Judge Amy Berman Jackson** of the U.S. District Court for the District of Columbia.

**US District Judge Angel Kelley**, a Biden appointee, issued a temporary restraining order to block Trump from slashing funding for universities and other research centers.

Last year the National Institutes of Health finally admitted to funding gain-of-function research at the Wuhan Institute of Virology, the ground zero for the COVID-19 pandemic.

A federal judge blocked the Trump Admin's move to cut billions in funding to the National Institute of Health (NIH).

US District Judge of the District Court for the District of Rhode Island, **John McConnell**, an Obama appointee, accused President Trump of violating his court order blocking his federal funding freeze.

Last month Judge McConnell temporarily blocked Trump's freeze on federal funding in response to a request from 22 Democrat state attorneys general and DC.

**US District Judge Joseph Laplante**, a George W. Bush appointee, granted a preliminary injunction and indefinitely blocked Trump's birthright citizenship executive order.

"[The] Fourteenth Amendment has never been interpreted to extend citizenship universally to everyone born within the United States. The Fourteenth Amendment has always excluded from birthright citizenship persons who were born in the United States but not "subject to the jurisdiction thereof." Consistent with this understanding, the Congress has further specified through legislation that "a person born in the United States, and subject to the jurisdiction thereof" is a national and citizen of the United States at birth, 8 U.S.C. 1401, generally mirroring the Fourteenth Amendment's text," the order stated.

**District Court Judge Kenneth J. Gonzales** decided to legislate from the bench to stop President Trump from carrying out his agenda.

As Fox News reported, a federal court in New Mexico issued a temporary restraining order barring the Trump administration from shipping three Venezuelan immigrants held in the state to Guantánamo Bay as part of Trump's efforts to rid America of illegal aliens.

in an egregious and unconstitutional assault on executive authority, **Judge Paul Engelmayer** has unilaterally forbidden all of Trump's political appointees—including Treasury Secretary Scott Bessent—from accessing Treasury Department data.

On Saturday, Obama appointee Judge Paul A. Engelmayer issued an ex parte temporary restraining order that restricted access to Treasury systems exclusively to "civil servants," explicitly excluding "all political appointees" from accessing these systems.

Ex parte means the “Trump administration lawyers weren’t given notice, weren’t allowed to argue, and weren’t even in the room. Only Democrat attorneys general were heard, ensuring a predetermined outcome.”
