  Partnerships suggested change to Policy and Procedure 1.2 ESIP

- Policies and Procedures have been drafted to ensure compliance with federal non-profit requirements in procurements, investments, audits and the handling of bank accounts.

#### **Endorsement Decision Tree**

- What does it mean to endorse likely need to document this; policy that Governance can work on but this group provides the philosophy and mindshare
  - "Corporate" section of P&P's, perhaps
  - Policy can be worked on by the Board too
  - Context on endorsement examples from our ESIP community
    - Ruth, Mark Mike can talk with these people
    - What were they getting out of endorsement
    - Language could be useful
- ESIP Staff should be empowered up to make the decision up to a certain point in the process
- Is it awkward to endorse something that is produced by an ESIP committee an ESIP product?
- Identifying some samples that illustrate the process
  - E.g., Force11 Data Citation Guidelines
  - Open Access policies might be more powerful for larger assembly to vote on
  - Power of a whole assembly saying with one voice more than approving, in some cases
- At what point does it need a Program Committee vote?

**ESIP logo discussion:** In reviewing some of the examples you all provided, what is your feedback on these items?

- 1. **Use:** when the logo should be used and when it shouldn't
  - i. By default, anything ESIP funds should get the logo: e.g., Lab, FUNding Friday, special projects, Presentations where ESIP sponsors...
  - ii. But what about other cases?
  - iii. And cases where the logo should not be used e.g., <u>UNAVCO's logo</u> <u>quidance page</u> had good language on this: "UNAVCO's logo cannot be used in a manner that falsely implies employment by or affiliation with UNAVCO. UNAVCO's logo cannot be used to imply or endorse a product or service."
  - iv. A note as part of the guidance: If you are using it, we'd love to know because it helps us share the ways ESIP is working in our community...
- 2. **Permission needed to use?** Program Committee agreed that no, we don't want to have a permission-granting process but instead follow the UNAVCO example. UNAVCO's page is clear about not requiring permission
  - <u>EarthCube's logo page</u> as well: "EarthCube logos made available free for use in posters, presentations, and any other non-commercial application."

- 3. **"For the press" information** (<u>OGC's page</u> encourages the press to engage well)
- 4. Etc.?
- In general Program Committee was supportive of logos being easily accessible, clearly documented for appropriate/inappropriate use, and not needing a permission workflow while still encouraging letting ESIP know
- Thus, ESIP Staff can proceed to work on the logo access and guidance

# Committee Reports

- Nominations Committee
  - Starting weekly calls for the committee next week for the Fall.
  - Publishing schedule for nominations next week.
  - Will be soliciting applicants in the weekly newsletters in addition to targeted outreach that is already underway.
- Governance Committee
  - Most recent telecon was August 21.
  - Revised Policy 1.3 (Nominations Committee changes) was approved by the Board and committed to GitHub.
  - The Committee reviewed a <u>proposed change to Policy 1.2</u> in regards to streamlining the partnership process. The Committee has some comments on this change that will be sent to Nancy.

- A <u>cheatsheet for adding new standing committee/working group rules and policies to the GitHub repo was created.</u>
- Instructions were created for modifying and logging approved changes for P&P documents in the GitHub repo.
- Several other policies are in various states of development:
  - Privacy and terms of use policies to address the General Data Protection Regulation (GDPR).
  - A policy and procedure for opening and closing ESIP bank accounts.
  - A <u>revision to P&P 3.5A</u> covering complimentary registrations.
  - Two policies on investment and procurement were requested by the auditor and need to be drafted by our accountant (P&P 3.6A and 3.6B, respectively).
  - Review of a <u>2003 document describing Board duties and</u>
     <u>responsibilities</u> to ensure that our existing Bylaws and P&P
     address these matters in a consistent way.
- Next telecon is September 18. The Governance Committee needs to have all policies requiring Board review and approval ready by October 2nd. Here is the procedure for suggesting amendments.

#### Partnership Committee

- On our last call, Erin reported that some on the Governance Committee were uncomfortable taking away the decisions about membership from the ESIP Assembly as it was one way that each Assembly member could have a vote. They were more comfortable with the existing process, but with a slight change to help improve the speed by which applicants received a response to their application for membership.
- After discussion, the Partnership Committee still recommends that the Policies & Procedures be changed to have the Executive Board make the decisions about accepting applicants as partners at each of the quarterly Board meetings for the following reasons:
  - The Assembly will still have the opportunity to read each of the applications during a required 4 week comment period; however, the Assembly should be urged to review the applicants from a more positive perspective than looking for problems, i.e., looking at applicants as potential collaborators and contributors to their own business interests and to the ESIP community efforts.
  - Each of the positions on the Executive Board are now elected, and so, are chosen by and responsible for representing Assembly interests following the definition of a republic style of governance versus a full democracy. Assembly members will still have the

- opportunity to voice their opinions to the elected officials via the comment period, and to individual members of the Board as well.
- The process of expressing concerns and recording responses should be very transparent, using, for example, the spreadsheet form that Partnership has adopted which is open to all at: <a href="https://docs.google.com/spreadsheets/d/1pVH9kMp-xc-Ktsl3yHC">https://docs.google.com/spreadsheets/d/1pVH9kMp-xc-Ktsl3yHC</a>

- The timeline for the process should also be very transparent and rigorous, i.e.,
  - Completed applications and any concerns noted and resolved by the Partnership Committee should be submitted to ESIP Staff 6 weeks before the next quarterly Board meeting; (by September 11th for the October 23rd Board meeting)
  - Assembly will have 4 weeks to review the current cohort of applicants and make comments; comments that require response will be made by ESIP Staff, passed along to the Partnership Committee, and recorded in the spreadsheet mentioned above within the 4 week time period. (by October 9th for the October 23rd Board meeting)
  - The Executive Board should receive information about each of the applicants that has been compiled by the Partnership Committee and ESIP Staff two weeks before the quarterly Board meeting. (by October 9th for the October 23rd Board meeting)

  - [BC] Some results: No real surprises. Because of ESIP's history, some ESIPs are subunits of larger organizations (e.g. NASA, NOAA, WHOI), which also have ESIP membership status. Others are subunits of organizations that are not ESIP members (e.g., UCSB). This can cause some confusion when new employees are registering for meetings (and need to know if they can use the member rate). Staff answers these queries on a case-by-case basis.

Keeping memberships for subunits when the larger organization is a member gives these subunits a vote. When the larger organization is a member, then this organization can also vote. As long as there is no organized attempt to game the voting, this causes no problem.

Travel to ESIP is mainly constrained by budget. Sometimes the travel is split among team members who might each attend one meeting. Staff/visioneers will examine suggestions about meeting logistics. Mostly members were well satisfied.
