

Provost's Office Research, Scholarly, and Creative Activities Awards (P-RSCA)

Project Narrative Guide

Overview

The Project Narrative is a critical component of your P-RSCA application. It must align with the P-RSCA Evaluation Rubric and clearly outline your proposed work, demonstrating how the project advances your scholarly, creative, or research activities while fostering innovation, community benefit, and academic excellence.

Please ensure that you are aware of both the general AND the specific requirements for the grant you are applying for.

Formatting Requirements

- Length: Maximum 2 pages (excluding references).
- Font: 11-point Arial or Times New Roman.
- Spacing: Single-spaced, 1-inch margins.
- Format: PDF

General Required Sections (Aligned with P-RSCA Rubric)

- 1. Introduction & Overview:** Provide a clear summary of your project, including objectives, goals, and anticipated outcomes.
- 2. Significance & Impact:** Explain the project's contribution to your discipline, Fresno State's community, and/or broader societal impact. Emphasize how the project fosters innovation and opens pathways for future funding or continued scholarly work.
- 3. Innovation & Originality:** Describe the unique aspects of your project, including novel approaches, creative frameworks, or original contributions. Highlight how the project advances knowledge, practice, or creative expression in your field.
- 4. Approach & Feasibility:** Outline your methods, timeline, and required resources, ensuring the project is realistic and achievable; if requesting WTUs or stipends, justify their necessity and specify the semesters of use.
- 5. Student Engagement:** Explain how undergraduate and/or graduate students will be involved. Detail their roles, responsibilities, and how the project enhances their educational experience.

Grant-Specific Requirements (in addition to the general requirements):

- **Impact Grants (\$15,000 each):** Emphasize how your project can generate meaningful outcomes that accelerate innovation, drive measurable change, and lay the groundwork for future funding

or scalability. Identify any transdisciplinary or cross-college partnerships. Describe each collaborator's role and contribution to the project's success.

- **WTU/Summer Stipend Grants (3WTUs or \$5,000 summer stipend):** If requesting 3 WTUs (academic year) or a \$5,000 summer stipend, provide clear justification, including timing, purpose, and deliverables.
- **Micro-Grants (up to \$2,500 each):** Focus on how the funding will support essential supplies, student assistance, and project-related activities leading to defined outcomes. WTU and Stipend requests are NOT allowable expenses for the Micro-Grants.

Applications per Faculty: 1 (Faculty may serve as either a PI or a Co-PI, but not on multiple applications. Example: If you apply for an Impact Grant, you may not apply for a WTU/Stipend Grant or Micro-Grant.)

Additional Requirements

- If submitting proposals for both P-RSCA and CO-RSCA competitions, each proposal *must* be unique.
