Interim Executive Director, ICLEI*Local Governments for Sustainability, USA 2009

In the midst of his 2009 book release in Canada, U.S., India, and Australia, Jeb was appointed from and by the ICLEI

USA Board of Directors to serve as interim Executive Director. Over a four year period, ICLEI USA had grown from a program office serving 65 municipal members to a full-service organization with 600 municipal members and a \$5 million budget. This growth could not be effectively managed within old structures, roles, and program models. A new Board of Directors confronted a breakdown in program efficacy, financial management, partnership management, and employee morale. Brugmann oversaw eight senior staff transitions, crisis communications, reestablishment of financial management systems and controls, stabilization of financial health, and execution of a Board-Management-Stakeholder organizational review. He fully reorganized an operation that included seven offices and also reorganized grant-funded programs, consulting services, and software development into distinct business units. His final task was to manage the recruitment and hiring of a new Executive Director and senior management team. During his seven month tenure he secured US\$1.5 million in grant funding for the organization. The Board repeatedly offered Jeb a more permanent position as Executive Director.

Founder/Owner, Access Distribution Private Limited (India), 2006-2007

Co-founder with two partners of this rural distribution and retail business in Maharashtra state, India. The business distributed goods representing some 50% of rural household expenditures to a trained network of 65 village retailers. First round venture investment was pending when the 2007 world food commodity crisis hit and eliminated margins due to small scale of start-up sourcing operations. Brugmann was unable to relocate family to India to provide the required leadership through this period. The business was converted into a social enterprise with a regional microfinance organization.
