**The Course:** The first quarter of this semester-long course will be spent exploring forensic criminology. We will investigate the various fields of study in forensic and this will culminate in the investigation of a crime.

The second quarter, we will explore the institutions that make up the legal system in the United States; including our country's courts on the local, state, and national level, our country's incarceration facilities, our civil and criminal laws, and how they

are enforced. This will culminate into a mock trial where we will put a suspect on trial.

In the 2nd quarter; we will examine the court system and follow cases as they make their way through the legal system. We will also attempt to understand the contradictions between the principles that created our democracy and the ways that some groups are marginalized, disenfranchised, and further oppressed using those very systems.

The Constitution deems "judicial power" as the privilege of "independent power to interpret and apply the Constitution." Alexander Hamilton argued that the judicial branch can only judge, without force or will.

Others argued that with this power, the courts could "mold the Constitution into whatever they wished it to be." The word *just* comes from the Latin root for *right*. Judicial power and interpretation is really about deciding what is right, just, and how justice should be enforced throughout the nation.

In the image on the left side of this page; Lady Justice wears a blindfold because justice is meant to be "impartial," in the same way that courts and judges are meant to weigh both support and opposition, without heed to any factors such as wealth, power, race, or other status.

### **Grades:**
