Community representatives: Officer Roman- crime down in near eastside and our neighborhood. IMPD is not enforcing immigration raids. When federal agencies come into a neighborhood and conduct police activities they normally give local authorities a courtesy heads up but do not require any assistance unless there is a public safety issue that effects the entire community- then IMPD would get involved. The governor's orders direct state police to be involved but local authorities (Marion county and Indianapolis) are not involved in enforcing. If anyone is interested in having Officer Roman come to their work or other organization for active shooter training feel free to reach out, they will do this free of charge.
