



School, Parent and Family Engagement Policy

In support of strengthening student academic achievement, Ellijay Elementary School receives Title I, Part A funds and therefore must jointly develop with, agree on with, and distribute to parents and family members of participating children a written parent and family engagement policy that contains information required by section 1116(b) and (c) of the Every Student Succeeds Act (ESSA). JOINTLY DEVELOPED

Ellijay Elementary School will take the following actions to involve parents in an organized, ongoing, and timely manner in the planning, review, and improvement of Title I programs, including opportunities for regular meetings, if requested by parents, to formulate suggestions and to participate, as appropriate, in decisions relating to the education of their child and respond to any such suggestions as soon as practicable possible.

EES worked with feedback from the parent survey conducted by our Family Engagement Partner, School Governance Team, and parent volunteers to update the 2025-2026 plan to include continued opportunities to build parent capacity. All parents and stakeholders were invited to the Stakeholder Input meetings on May 29, 2025, in the morning and afternoon to provide their input. Invitations to the meetings were extended through the school Facebook page, school website, and text blast. This input, coupled with LEA and state guidelines allowed for a coordinated approach to the EES School, Parent, and Family Engagement Policy. As may be necessary, this plan may be altered and changed to meet the ever changing needs of the school and parents. Each year at a minimum, the plan will be revisited and updated.

ANNUAL TITLE I MEETING

Ellijay Elementary School will take the following actions to conduct an annual meeting, at a convenient time, and encourage and invite all parents of participating children to attend to inform them about the school's Title I program, the nature of the Title I program, the parents' requirements, the school parent and family engagement policy, the schoolwide plan, and the school-parent compact.

EES will hold an annual Title I meeting for parents. This meeting will be held during open house to provide information about Title I at the start of the school year. Translators will be available for parents, guardians, or students if needed. At this meeting parents and guardians will receive information regarding the implementation and requirements of the school-wide Title I program specifically at EES.

Ellijay Elementary School will take the following actions to provide parents of participating children the following:

Communication at EES is of particular importance. The EES Parent and Family Engagement Policy will be kept on the school's website at all times for downloading. Paper copies are available for parent pickup, located in the school's front office where parents check in/out students each day. Notice of these methods of attaining the Parent and Family Engagement Policy will be given to parents through email, text blasts, the school's Facebook page, and the school's website. Also, the school uses these same modes of communication to disseminate information regarding family night events and other important school information to parents and guardians. Starting with the 2025-2026 school year, one communication platform called Parent Square will be used for all school-wide communication within the school district.

SCHOOL-PARENT COMPACT

Ellijay Elementary School will take the following actions to jointly develop with parents of participating children a school-parent compact that outlines how parents, the entire school staff, and students will share the responsibility for improved student academic achievement and the means by which the school and parents will build and develop a partnership to help children achieve the state's high standards.

In April and May of 2025, the Ellijay Elementary School Parent Survey was completed. Results from this survey informed our School-Parent Compact through suggestions made directly by parents and guardians of our students. All parents, guardians, and stakeholders were invited to the May 2025 Stakeholder Input Meetings on May 29, 2025. At those meetings, survey results and compact needs were discussed collaboratively with stakeholders and school personnel for them to develop this year's School-Parent Compact. Additionally, teachers provided suggestions in academic areas for each grade level where they felt it would best benefit students to have more support at home from parents/guardians. Parents, guardians, and all stakeholders are invited each month to attend school governance meetings to gather their valuable input. With this input, the school can better serve the needs of all parents, guardians, and students.

RESERVATION OF FUNDS

Ellijay Elementary School will take the following actions to involve the parents of children served in Title I, Part A schools in decisions about how the 1 percent of Title I, Part A funds reserved for parent and family engagement is spent by:

The reservation of funds is discussed each year at the last School Governance Team (SGT) meeting in April 2025 and at the EES Parent Input meetings on May 29, 2025. All parents and stakeholders are invited to all SGT meetings at EES. In the fall prior to November 1st, approval is sought from all parents of EES to reserve that 1% of budgeted funds and allow for the district to delegate those monies. The Gilmer County Charter School System uses its 1% to partially fund school family engagement partners and a district level family engagement coordinator.

COORDINATION OF SERVICES

Ellijay Elementary School will, to the extent feasible and appropriate, coordinate and integrate parent and family engagement programs and activities with other Federal, State, and local programs, including public preschool programs, and conduct other activities, such as parent resource centers, that encourage and support parents in more fully participating in the education of their children by:

Ellijay Elementary School has partnered with several local groups to enhance services to students and families. Gilmer Arts has provided performances to all students in the building utilizing our school auditorium. Local counseling agencies offer services to families and students through referrals made by the school. EES maintains a parent resource center containing meaningful parent focused literature as well as a computer capable of printing. EES plans to continue partnering with various community partners during parent engagement events throughout the school year to continue building parent capacity for both the academic needs and well being of our students and families by providing access to resources available within the community.

BUILDING CAPACITY OF PARENTS

BUILDING CAPACITY OF SCHOOL STAFF

Ellijay Elementary School will provide training to educate teachers, specialized instructional support personnel, principals, and other school leaders, and other staff, with the assistance of parents, in the value and utility of contributions of parents, and in how to reach out to, communicate with, and work with parents as equal partners, implement and coordinate parent programs, and build ties between parents and the school by:

Each month at the Ellijay Elementary School School Governance Team (SGT) meetings, parents provide input and direct a portion of the meeting. All stakeholders and parents are invited to attend the SGT meeting each month. This portion of the meeting that is directed by parents typically revolves around an outreach article selected by parents that discusses the value of including parents in their child's education using various methods. This conversation often involves school and home communication, the use and understanding of tests and test scores, school attendance, curriculum and standards, and others. To continue to foster parent involvement and strong school-home partnerships, EES will promote opportunities for two-way communication in the form of parent/teacher conferences, whether in person, virtual, or via phone. Not only will these conferences allow the sharing of academic and behavioral progress and help set goals for students, but will also help to build a trusting relationship between parents and teachers.
