# Treaty of Mutrial Cooperation and Recognition between The Sovereign Municipality of Ameristralia And the Republic of The Sohnland

The Signatories Formally Establish Diplomatic Relations for the Purpose of Cooperation and Recognition

Of Governance, Legitimacy, and Sovereignty

## Article I. The Parties

The Sovereign Municipality of

Ameristralia heretofore referred to as
Ameristralia, and the Republic of The Sohnland
heretofore referred to as The Sohnland for the
purposes of this document, enter into this treaty
by the effect of the signature of authorised
persons.

## Article II. Recognition

The governments of the signatory nations are the legitimate and legally empowered representatives of their people and their sovereignty. The nations agree to formally recognise the legal independence and sovereign existence of the government, the land claims, and the people of the signatory nations. Ameristralia and The Sohnland acknowledge the institutions, laws, and authority of the signatory nations.

### Article III. Bilateral Continuation of Terms

The signatory nations commit to the continued development of ties between the parties for mutual benefit and collaboration for the improvement of their people and institutions, and so the micronational sphere in general practice. The parties agree to therefore establish a permanent line of communication for diplomatic purposes.

Article IV. Establishment of Diplomatic Missions, Credentials, and Officers

The signatory nations, to adhere to the terms of this document, shall establish by agreed procedure diplomatic missions, serve formal diplomatic credentials, and provide government officers for government representation and services.

# Article V. Diplomatic Immunity

The signatory nations agree to extend diplomatic immunity to the other's Heads of State, leaders of Government, High ranking Government officials, and other credentialed officials, to include full immunity from prosecution of criminal acts which may have been committed in the other nation's jurisdiction. Immunity for all government officials, except for the Head of State, may be waived with cause, by agreement of both signatory nations.

## Article VI. Human Rights

The signatory nations agree in principle that the fair treatment of citizens and the protection of human rights is the foundation of freedom and justice. The parties, therefore, agree that the fundamental rights of people shall not be accosted by a government. The parties denounce the degradation of human rights and the unfair and harmful treatment of individuals and groups of people.

## Article VII. Non-Aggression

The signatory nations agree to a principle of non-aggression between the parties to utilise and exhaust established diplomatic channels or international mediation to resolve conflicts.

# Article VIII. Dissolution and Termination of Agreement

The signatory nations agree that the agreement shall terminate upon the dissolution of the nation of either party. A signatory nation may terminate the agreement without cause at any time, with at least 72 hours of prior notice to the other party, through officially established communication channels.

## Article IX. Mutual Aid

The signatory nations agree to provide mutual humanitarian aid to each other in times of need, including war, political strife, or general need. It is the right of all signatory nations to reject such a request should it potentially cause issues within their nation.

## Article X. Right of

The signatory nations of this treaty have the right to enter into diplomatic relations with other nations should they choose, as well as negotiate any acts or amendments to the standard treaty on behalf of their state should the need arise, as long as all parties agree.

# Article XI. Currency

The signatory nations agree to the fair exchange and use of each other's currency for the purpose of trade and travel.

## Article XI. Effective Term of Treaty

The signatory nations agree to the renegotiation of terms after a period not to exceed three years, or should either party feel the need arises. The treaty shall take effect upon ratification according to the institutional procedures of the parties, per the laws and regulations of the government.

### Article XIII. Affirmation

The signatory nations, by the authorised signatures, affixed, agree to the terms of the Treaty of Mutual Cooperation and Recognition between the Sovereign Municipality of Ameristralia and the Republic of the Sohnland, on the Twenty-sixth day of the month of March in the year Two-thousand twenty-three of the Common Era.
