Grant application is due March 31st and is being worked on. One year planning grant with some activities and workshops. A group will be created to make decisions on where the funding is spent.

The Cabot school board will decide who will represent the board.

Outreach from Twinfield School Board (Discussion) - Read the outreach from February 9.

Ellen thought it would be good to have a general conversation. Alicia noted it would be good to survey the community to see where their thoughts are at. A survey would be a good way to start involving the community. Twinfield has started conversations with U32. Chris recommended meeting with the
