Pest	Non-Chemical Practices
Ants	Remove food sources, seal cracks, manage irrigation, non-chemical sprays
Mice	Fix leaks, install physical barriers, use traps

Chemical Pest Management Practices

Chemical pesticides are used only if non-chemical methods prove ineffective and pest levels exceed action thresholds. All products are applied in a manner that minimizes risks.
