For in text citation use the author's name and year (Author, 2020), for direct quotes "provide the author's name, year, and the page number" (Author, 2020, p. 24). For citing more than one reference, the authors' name should be written in alphabetical order (Alpha, 2020; Beta, 2020). For a reference that is up to five author, mention all of the authors name in the first instance (Author 1, Author 2, Author 3, Author 4, Author 5), the use first author et al. subsequently (Author 2 et al. 2020). **Do not use footnotes.**

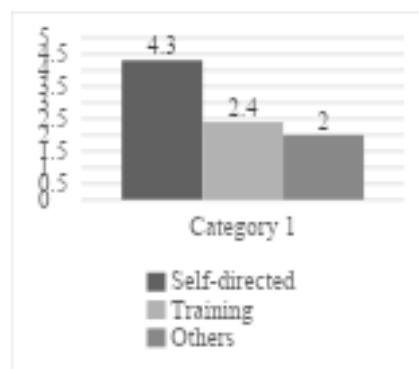


Figure 1. Types of CPD taken by teachers from 2015 to 2020
